2. Approve the plans and specifications for the construction of the La Sierra Avenue Resurfacing Project in the Lake Hills Community; and
3. Authorize the Clerk of the Board to advertise for bids to be received by the office of the Director of Transportation and Land Management at the Transportation Annex located at 3525 14th Street, Riverside, CA 92501. All bids must be received up to the hour of 2:00 p.m., Wednesday, August 22, 2018 at which time bids will be opened; and
4. Direct the Clerk of the Board of Supervisors to file the Notice of Exemption with the County Clerk for posting within five (5) working days.

BACKGROUND:

Summary

The County Transportation Improvement Program (TIP) provides for the La Sierra Avenue Resurfacing Project in the Lake Hills Community. The project limits are El Sobrante Road to County of Riverside/City of Riverside boundary (approximately 200-feet North of Middleborough Road), approximately 2.4 miles. The project will remove the existing asphalt pavement and place 0.17' of rubberized hot mix asphalt pavement overlay. Additionally, the project will include improvements to roadway drainage, traffic safety, and sixteen existing curb ramps will be replaced to comply with the Americans with Disability Act (ADA) standards.

A portion of La Sierra Avenue is in the City of Riverside. The City portion includes the easterly half of the street, from Cleveland Avenue to the north end of this project (approximately 200-feet North of Middleborough Road). The City was invited to participate in the resurfacing of their half of the street but declined.

On April 28, 2017, Senate Bill 1 (SB1) was passed to improve the state's aging transportation infrastructure, particularly roads and bridges. Because of this, the County is now able to improve the condition of roads in need of resurfacing or reconstruction and has included them in the County Transportation Improvement Program (TIP). The La Sierra Avenue resurfacing project is urgently needed to improve this aging road in a state of disrepair. Without SB1, urgently needed road repair projects would have been shelved until funding became available.

The submitted plans and specifications have been approved as to form by County Counsel.

The bid documents include the following bid schedules of work:

Base Bid Schedule 1: La Sierra Avenue resurfacing and associated road improvements

Alternate Bid Schedule 1: Utility adjustments to grade (Western Municipal Water District)

Alternate Bid Schedule 2: Utility adjustments to grade (AT&T)

The adjustment of manholes and utility covers owned by the Western Municipal Water District (WMWD) and AT&T, respectively, are included in the bid package as alternate bids schedules. If WMWD and AT&T approve the award of their respective alternate bid schedules, as bid by the apparent low bidder, the costs for the work will be funded by the utility owners through a reimbursement agreement, which will be processed prior to the Board of Supervisors approval or concurrent with the award of the construction contract.

The Transportation Department will select the contractor based upon the lowest responsive and responsible bid of the sum of all bid schedules.

Environmental Findings

The County Transportation Department is requesting that the Board approve the Notice of Exemption which documents that the project consists of the maintenance, repair and minor alteration of an existing public facility and is exempt under Section 15301 (c) of the CEQA Guidelines.

Impact on Citizens and Businesses

The purpose of this project is to rehabilitate deteriorated segments of La Sierra Avenue from El Sobrante Road to County of Riverside/City of Riverside boundary (approximately 200-feet North of Middleborough Road) to provide the public with a smooth paved roadway that will improve the safety and efficiency of vehicular traffic.

The work is scheduled to begin in fall of 2018, and will be phased to keep the road open during construction as much as possible and will take approximately six weeks to complete.

Additional Fiscal Information

The construction contract is estimated to cost approximately \$2,278,730 and will be funded with Gas Tax/SB-1 funds.

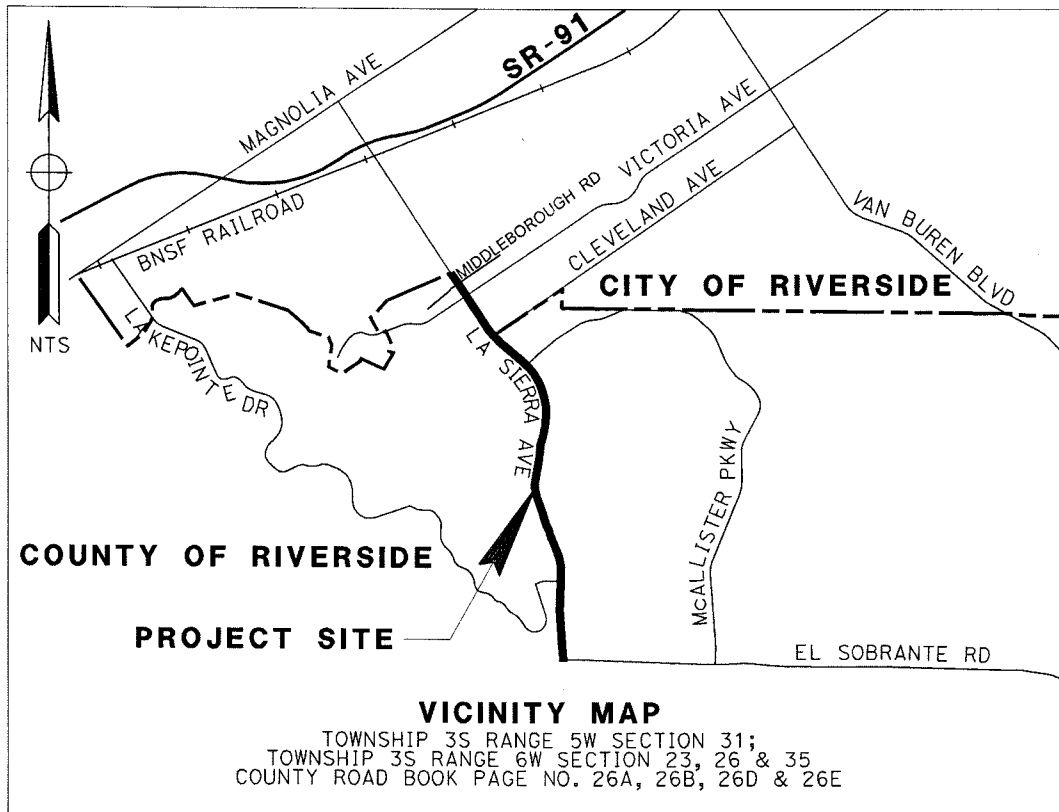
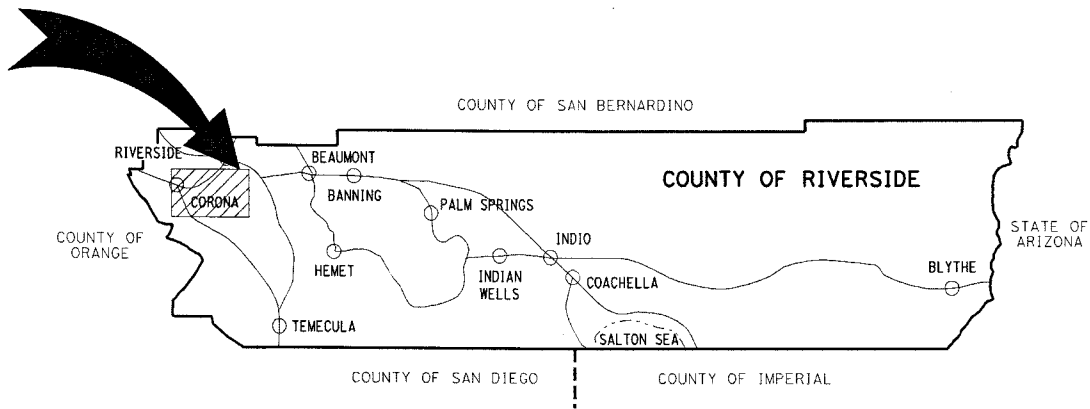

PROJECT DESCRIPTION: The Riverside County Transportation Department (RCTD) proposes to resurface approximately 2.4 miles of La Sierra Avenue from El Sobrante Road to the County of Riverside/City of Riverside boundary. La Sierra Avenue is classified as an Arterial in the County of Riverside General Plan. La Sierra Avenue currently ranges from 64-86 feet wide with dike, curb/gutter, and sidewalk at various segments of the roadway. The proposed project includes grinding the roadway width and paving with Hot Mix Asphalt (HMA). The project will include the following:

- Reconstruction of asphalt concrete over side drain, dike, driveway, and down drain pipe
- Reconstruction of concrete driveway, non-compliant ADA ramps, spandrel, and cross gutter
- Placement of centerline rumble strip
- Detector loops
- Utility adjustments
- Striping of roadway, including pavement markers and reflectors
- Salvage/removal and installation of new signs

ENVIRONMENTAL ANALYSIS:

The proposed project will be constructed within existing County right of way. The project will raise the profile of the roadway by 0.02 feet.

This project is subject to compliance with the Western Riverside County MSHCP. In accordance with Section 7.1 of the Western Riverside County MSHCP, necessary operation and maintenance along existing roadways are considered a covered activity outside cell criteria areas. This project is considered to be a safety improvement project under operation and maintenance and therefore is a covered activity. The project will comply with MSHCP construction guidelines and BMP's.

The Riverside County Transportation Department Staff conducted a review of the above referenced project and has determined that the proposal qualifies for a Categorical Exemption per the California Environmental Quality Act (CEQA) Guidelines.

The Riverside County Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEQA), based on the following:

Section 15301 (c) – Existing Facilities – The project proposes to resurface La Sierra Avenue. This minor improvement to the existing roadway involves negligible or no expansion of use and is exempt from CEQA under Section 15301 (c). The improvements are consistent with Section 15301(c) because the project is repair and maintenance of an existing road and associated facilities.
