BACKGROUND:

Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports economic expansion and the development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the WDB's members must come from the business community. In addition, WDBs are required to have representation from universities or community colleges and other training providers, as well as economic development and workforce program leaders. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official (CLEO), is responsible for appointing the WDB members for two year terms.

Mr. Layne Arthur is the Vice President of Balfour Beatty and currently serves as WDB member and Chair of the WDB East Regional Committee. He has been a strong supporter and active member of the WDB. His awareness of current and emerging requirements for the construction

industry is an asset to the WDB. He has been active and effective in connecting the WDB not only with the construction industry in the Coachella Valley, but also other key industry sectors identified by the WDB. He has been influential in bringing together panel members from these key industry sectors to regional committee meetings to highlight industry challenges. His extensive background in construction and education align with the WDB roles, connecting industry, education and workforce.

Mr. Layne Arthur, has expressed interest in being reappointed as a Private Sector Representative for the Workforce Development Board in District Four. If reappointed he will serve a two year term commencing August 28, 2018 and expiring August 28, 2020.
