

BACKGROUND: Community Improvement Designation funds will be allocated to the following organizations:

1. **Riverside County Foundation on Aging - \$3,000** funds will be used to assist the Foundation with their Holiday Gift Program. Through this Program, seniors are selected from each senior center in the 1st District to receive a Stater Bros. gift card to be used for the holidays. Gift cards will be purchased and distributed to the following centers: Lake Elsinore, Wildomar, Arlanza, Good Hope, Mead Valley, La Sierra, Stratton, Ysmael Villegas.
2. **Smiles for Seniors Foundation- \$1,000** to support their efforts of providing emergency assistance for food, housing and utility payments as well as home and auto repair, and to help pay for life saving prescriptions, and medical equipment for senior citizens in the 1st District.
3. **Evergreen Memorial Historic Cemetery - \$1,000** funds will be used to support long-term care for the cemetery which is needed to preserve the cemetery as a significant cultural and historic resource for the area.
4. **Office of the Mayor, City of Riverside - \$5,000** funds will be used to assist in the city's pilot program that will place social work students at faith-based organizations to provide outreach, housing and other needed services to homeless and low income individuals in the First District.
