

BACKGROUND: Community Improvement Designation funds will be allocated to the following organizations:

1. **Hospice of the Valleys - \$1,500** funds will be used to offset the cost of hospice support for underinsured and uninsured patients of the 1st District. Specifically the funds will be used to help cover the costs of unreimbursed supplies and equipment, community education and bereavement costs not otherwise covered by insurance.

2. **Riverside Medical Clinic Charitable Foundation- \$1,000** funding will be used to provide training to educators, law enforcement, youth leaders, and community representatives who are committed to ending bullying.

3. **Riverside University Health System Foundation - \$2,500** funding will be used to assist Riverside University Health System - Medical Center with specialized medical equipment.

4. **Riverside National Cemetery Support Committee - \$2,500** funds will be used to assist with the maintenance and operations of the Riverside National Cemetery.
