

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Western Center Community Foundation - \$5,000 the funding will be used for Science Education Experience to engage students and the public in hands-on science lessons and activities.
2. Hemet Sunset Rotary- \$1,000 the funding will be used to sponsor the Festival of Frights event and the proceeds for this event will provide scholarships and improvements in the parks and Ramona Bowl.
3. Riverside County Economic Development Agency - \$2,500 the funding will be utilized for the 2018 State of the County, which will highlight current economic development activity and projects within the County.
4. 3rd District Discretionary Fund - \$2,500 the funding will be used to assist non-profit community partners find that they are short of resources and are unable to assist with emergency funds to pay utility payments, food, and emergency disasters for community members. This fund is to help offset the gap when non-profit agencies have exhausted their resources.
5. City of Hemet - \$2,500 the funding will be used for sponsorship of the Hemet Christmas Parade.
