

6. Menifee Valley Historical Association support will assist with identifying and preserving historical sites throughout the City of Menifee that will provide educational information to the public.
7. Riverside County Economic Development Agency support will be used towards creating, managing, and executing the 2018 State of Riverside County that will explore collaborate economic development and investment possibilities in the region as well as enhance the quality of life for area residents.
