BACKGROUND:

Summary

From September 20, 2002 (3.32) through October 17, 2017 (3.16) the Board has accepted grant funding for the Riverside County Off-Highway Vehicle Enforcement program. On April 24, 2018 (3.36), the Board adopted Resolution #2018-053, which authorized the Sheriff to apply for \$202,711 in grant funds from the State to continue the specialized patrol program in all five Supervisorial Districts and authorized the Sheriff or his designee to execute the grant agreement.

In response to the County's application, the California Department of Parks and Recreation has now awarded the Sheriff's Department \$96,668. The grantor requires a County cash or in-kind match of at least 25% of program costs. The Sheriff's Department contribution is 25% of program costs and will utilize budgeted ROVE Sergeant and sworn staff regular salaries for the County's in-kind grant match of \$32,222. A total project cost of \$128,890.

Schedule A details budget adjustments in the amount of \$96,668. The grant performance period is from 8/1/18 to 7/31/19 and grant funds will be totally expended in fiscal year 2018/19.

Impact on Residents and Businesses

The grant funds 75% of total project cost. The Off-Highway Vehicle Enforcement Grant Program focus is to enforce laws concerning illegal off-highway driving, dumping, driving under the influence and environmental destruction.

Additional Fiscal Information

Grant funding from California Department of Parks and Recreation, Off-Highway Motor Vehicle Enforcement Program will allow of enforcement of illegal off-highway driving and education with minimal county costs.
