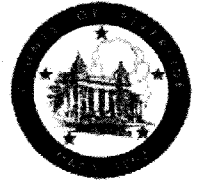

MEETINGS:

The Riverside County Regional Park & Open-Space Trails Committee met quarterly at Crestmore Manor in Jurupa Valley in August and December, 2017 and February 2018. The Committee met in April, 2018, at Kay Cenicerros Senior Center, Menifee.

TRAILS COMMITTEE ACTIONS for 2017-18:

- elected Trails Committee officers for FY 2017-18
- approved the Trails Committee Meeting Calendar for FY 2017-18

COMMITTEE MEMBERS & COMMUNITY INVOLVEMENT:

Committee members supported the Park District by attending events throughout the year.

In addition to the subcommittees, members of the Trails Committee actively participated in community events including trail user meetings, trail rides, races, and Adopt-A-Trail events.

The Committee provided feedback to District Planning staff on projects such as the Salt Creek Trail project, Santa Ana River Trail, and Countywide Comprehensive Trails Plan.

OVERALL COMMITTEE ACTIVITIES:

On Tuesday, August 29, 2017 the Riverside County Board of Supervisors adopted resolution 2017-189 and dissolved the County Trails Committee to allow the District to reconstruct the committee in a way that better reflects constituent expectations. The committee now consists of five members instead of eleven, and meeting locations alternate between Districts. The meeting time was moved from 6:30pm to 1:30pm to encourage stronger attendance at quarterly meetings and the ability to conduct site visits during daytime hours.

The Trails Committee continues to promote the Riverside County Adopt-A-Trail Program, and to advocate for the preservation and expansion of trails supporting hikers, bikers, equestrians, and all non-motorized users throughout the County – especially trails connecting communities, such as the Santa Ana River Trail and Salt Creek Trail.

The Trails Committee participated in a joint workshop regarding the countywide Comprehensive Trails Plan with the District Advisory Commission on February 1, 2018. The Trails Committee has worked in partnership with County departments to enhance efforts to provide, protect, and maintain the multi-use trail systems throughout the County.

The Trails Committee wishes to continue to serve the people of Riverside County by being actively involved as members of the Riverside County Trails Committee and representing the varied interests of all trail users when considering trial programs and development.

COMMISSIONERS & COMMUNITY INVOLVEMENT:



OVERALL COMMISSION ACTIVITIES:


