After serving as lead counsel in over 20 jury trials, he was invited to join two professional legal societies; the American College of Trial Lawyers and the American Board of Trial Advocates.

An inspirational force in the legal community, David will always be remembered as a "Super Lawyer" and as one of "The Best Lawyers in America." He mentored many young attorneys and served as President of the Riverside County Bar Association and as President of the Leo A. Deegan Inn of Court.
