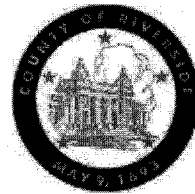



BACKGROUND:

1.
