BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Friends of the Date Festival - \$1,000 the funding will be used for educational scholarships for young people who participate with Riverside County Fair and National Date Festival.
2. Riverside National Cemetery Support Committee - \$2,500 the funding will be utilize to purchase needed equipment to provide dignified and respectful burials for veterans and their families at Riverside National Cemetery.
3. California VFW Motorcycle Club - \$2,500 the funding will be used to purchase and deliver food boxes to veterans, seniors within Southwest Riverside County.
4. Murrieta Chamber of Commerce - \$1,000 will be used for sponsorship of the 2018 Annual Awards Dinner that promotes and acknowledges businesses contribution to the economic development of the Southwest Riverside County area.
5. Voices for Children - \$5,000 the funding will be utilized to support the Court Appointed Special Advocates for hundreds of children in Riverside County's foster care system. The volunteer advocates, many times, are the only voice some foster children have to care for them.
