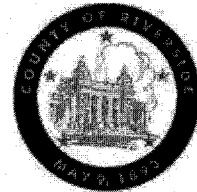

1. 2. Approve Resolution No. 2018-057, Authorizing the Resolution of Necessity for the Cajalco Road Interim Safety Project;
3. Allocate the sum of \$243,088 for deposits to the State Condemnation Fund; and
4. Authorize reimbursement to the Economic Development Agency-Real Estate (EDA-RE) for costs not-to-exceed \$10,500 in due diligence expenses and \$10,000 in time.

BACKGROUND:

Summary

The Riverside County Transportation Department (RCTD) proposes to construct a center (two-way) turn lane and right and left turn pockets along Cajalco Road from Brown to Day Street in the unincorporated county area of Mead Valley (Project). Reference is made to Exhibit A, Vicinity Map.

The proposed Project will include the construction of new pavements, striping and signing modifications, relocation of utility lines, the installation of bus stops at the major intersections, limited Americans with Disabilities Act (ADA) compliant sidewalks at the Clark Street intersection, and the relocation of existing traffic signals at Brown Street and Clark Street.

At its meeting on July 11, 2017 (Item 3.29), the Riverside County Board of Supervisors found the Cajalco Road Interim Safety Project categorically exempt from CEQA pursuant to CEQA Guidelines Section 15301(c) Existing Facilities and no further documentation is required under CEQA.

The Economic Development Agency-Real Estate Division (EDA-RE) has presented written offers to the property owners as required by Government Code section 7267.2. The amount of the offers is consistent with current property values in the Mead Valley area and is based upon fair market value appraisal reports. EDA-RE has also offered to pay the reasonable costs, not-to-exceed \$5,000, for independent appraisals obtained by the property owners as required by Code of Civil Procedure section 1263.025.

Settlement has been reached with the following property owners and these transactions are currently in escrow, pending owner's submittal of necessary documents to close escrow. EDA-RE will continue to work with the owners in an effort to close the escrow. If escrow is closed during the notification period and the public hearing, the County will not deem it necessary to continue with legal proceedings. However, staff recommends including these properties due to potential unforeseen delays to close escrow and obtain possession of the needed portion of the property.

Additional Fiscal Information

The amount of \$243,088 represents the deposits to be made to the State Condemnation Fund for the acquisition of the property interests referenced above. These costs are not reimbursable to EDA-Real Estate as they are paid directly by the Transportation Department. The remaining costs in the amount of \$20,500 are reimbursable to EDA-Real Estate. The following summarizes the funding necessary for the deposits to the State Condemnation Fund for the properties referenced above as well as due diligence and staff time during the condemnation process.


All costs associated with the deposits of these properties are fully funded by the Gas Tax (ABX8-9 Mar 2010 New Huta) in Transportation Department's budget for FY 2018/19. No net County costs will be incurred as a result of this transaction. These charges are estimates only and only actual amounts will be charged to the Project.

WHEREAS, the statutes that authorize the County of Riverside to acquire the Subject Property Interests by eminent domain include Article 1, Section 19 of the California Constitution; Section 25350.5 of the Government Code; Section 760 of the Streets and Highways Code; and Sections 1240.010, 1240.020, 1240.030, 1240.040, 1240.110, 1240.410, 1240.510, and 1240.610 of the Code of Civil Procedure.

Now, therefore, **BE IT RESOLVED AND ORDERED** as follows by the Board of Supervisors of Riverside County, State of California, not less than four/fifths of all members concurring, in regular session assembled on September 11, 2018, that this Board finds and determines each of the following:

1. Notice of the Board's intention to adopt this resolution of necessity was duly given as required by Section 1245.235 of the Code of Civil Procedure and, on the date and at the time and place fixed for hearing, this Board did hear and consider all of the evidence presented.

- (a) That the public interest and necessity require the Project;
- (b) That the Project is planned or located in the manner that will be most compatible with the greatest public good and the least private injury;
- (c) That the Subject Property Interests are necessary for the Project;
- (d) That the offers required by Section 7267.2 of the Government Code have been made to the owners of record of the Subject Properties;
- (e) That, to the extent that the Subject Properties are already devoted to a public use, the use of the Project is a compatible use that will not unreasonably interfere with or impair the continuance of the public use as it presently exists or may reasonably be expected to exist in the future (California Code of Civil Procedure

1 Section 1240.510) or the use of the Project is a more necessary public use than is the
2 presently existing public use (California Code of Civil Procedure Section 1240.610);

3 2. If (within 15 days from the mailing of this Notice) you file a written request
4 to appear at the public hearing and be heard on the matters described above in 1(a),
5 1(b), 1(c), 1(d), 1(e), (or any one or more of them), you will have a right to appear at
6 that meeting and be heard on those matters.

7 3. On July 11, 2017, the Board of Supervisors approved Item 3.29 that
8 found the Cajalco Road Interim Safety Project is categorically exempt from CEQA
9 pursuant to State CEQA Guidelines Section 15301(c) Existing Facilities and no further
10 documentation is required under CEQA.

11 4. That acquisition of the Subject Property Interests will promote the
12 interests of the County of Riverside.

13 BE IT FURTHER RESOLVED AND ORDERED that the County Counsel of the
14 County of Riverside is hereby authorized and empowered:

15 1. To acquire the Subject Property Interests by condemnation in accordance
16 with the Constitution and laws relating to eminent domain;

17 2. To prepare and prosecute in the name of the County such proceedings in
18 the proper court having jurisdiction thereof as are necessary for such acquisition;

19 3. To make application to the Court for an order to deposit the probable
20 amount of compensation out of proper funds under the control of the County into the
21 Condemnation Deposits Fund with the Office of the State Treasurer and to make
22 application to the Court and for an order permitting the County to take prejudgment
23 possession and use the Subject Property Interests for the purpose of constructing the
24 Project;

25 4. To compromise and settle such proceedings if such settlement can be
26 reached and in that event, to take all necessary actions to complete the acquisition,
27 including stipulations as to judgment and other matters and the causing of all payments
28 to be made.



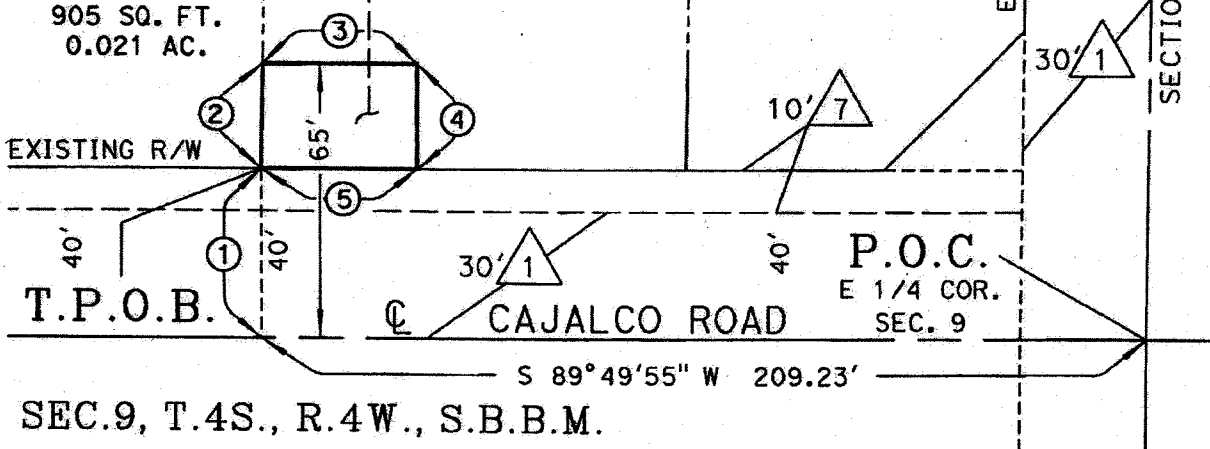
