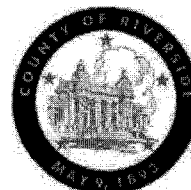





BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Equality California advances LGBTQ civil rights and social justice by inspiring, advocating, and mobilizing through an inclusive movement. Equality California will be hosting the annual 2018 Palm Springs Equality Awards on October 13, 2018, to honor the inspirational leaders and outstanding allied organizations whose selfless work helps create a more fair and justice society. CID funds will be utilized towards their operating and lobbying efforts.
2. The City of Palm Springs will host the 22nd Annual Veterans Day Parade on November 11, 2018. This parade honors all who served and provides an opportunity for the community to say thank you to all our veterans for their service. CID funds will be used towards parade expenses such as staging, pyrotechnics, lighting, sound, advertising and CHP staffing.
3. The Inland Empire Ronald McDonald House is hosting the annual A Few Good Men gala, honoring a number of distinguished gentlemen whose generous contributions to the communities they serve are worthy of special recognition and appreciation. The CID funds will support the "Home Away from Home" for Coachella Valley families of critically ill children undergoing treatment at Children's Hospital in Loma Linda. Families are provided with housing and through this program are able to create a network of social support for one another.
4. The Riverside County Economic Development Agency's mission is to enhance the economic position of the County and its residents, while maintaining the environment and quality of life. The 2018 State of Riverside County highlighted current economic development activity and projects within the County. CID funds will be used to offset event costs incurred to create, manage and execute this annual event.
5. Riverside University Health System Foundation will be hosting the annual Festival of Trees from November 23rd through November 25th, 2018. The fundraiser helps purchase of desperately needed and often lifesaving equipment for the children's units at the Riverside University Health System Medical Center. CID funding will be used toward the expansion of the Child Abuse and Neglect Units.
