

RECOMMENDED MOTION: That the Board of Supervisors:

1. Accept as complete the Construction of Landfill Gas Collection System Expansion for Fiscal Year 2017/2018 Phase 1 at the Lamb Canyon Sanitary Landfill and Construction of Landfill Gas Collection System Expansion for Fiscal Year 2017/2018 Phase 2 at the Badlands Sanitary Landfill by Aptim Environmental & Infrastructure, Inc., and authorize the Chairman to execute the attached Notice of Completions for each location;
2. Authorize the release of retained funds to the contractor, Aptim Environmental & Infrastructure, Inc., in the amount of \$7,986.58 for the above referenced phases of work in accordance with the contract terms and applicable law; and
3. Direct the Clerk of the Board to record the executed Notice of Completions for each location and, upon recordation, return the conformed copies to the Department.

BACKGROUND:

Summary

On March 20, 2018, the Board awarded Aptim Environmental & Infrastructure, Inc., a three-year contract for Construction of Landfill Gas Collection System Components at the Badlands, Highgrove, and Lamb Canyon Sanitary Landfills and as needed Perimeter Probe Installation at all Department Landfills.

Construction of the Landfill Gas Collection System Expansion for Fiscal Year 2017/2018 Phase 1 at the Lamb Canyon Sanitary Landfill was satisfactorily completed by Aptim Environmental & Infrastructure, Inc. at a cost of \$101,148.50 (Retained Funds of \$5,057.43) and staff recommends approval of the Notice of Completion. The Notice of Completion here is for completed work associated with a Notice to Proceed dated 05/22/18.

Construction of the Landfill Gas Collection System Expansion for Fiscal Year 2017/2018 Phase 2 at the Badlands Sanitary Landfill was satisfactorily completed by Aptim Environmental & Infrastructure, Inc. at a cost of \$58,583.00 (Retained Funds of \$2,929.15) and staff therefore recommends approval of the Notice of Completion. The Notice of Completion here is for completed work associated with a Notice to Proceed dated 05/18/18.

Impact on Residents and Businesses

This contract ensures the Department's ability to efficiently collect the landfill gas generated at the Badlands, Highgrove, and Lamb Canyon Landfills and to monitor the landfill gas migration at all Department Landfills to maintain compliance with air quality regulations.

SUPPLEMENTAL:

Additional Fiscal Information

This is an administrative action to file the Notice of Completions for only the Construction of Landfill Gas Collection System Expansion Fiscal Year 2017/2018 Phase 1 at the Lamb Canyon Sanitary Landfill and Construction of Landfill Gas Collection System Expansion for Fiscal Year 2017/2018 Phase 2 at the Badlands Sanitary Landfill. No funds are being requested.

Under this contract to date, a total of one (1) construction phase has been completed at the Badlands Landfill and one (1) construction phase at the Lamb Canyon Landfill. A cost summary by construction phase and location is summarized below. The total amount of the contract expended to date is \$159,731.50. The remaining contract amount is \$1,454,563.50.




