On motion of Supervisor Tavaglione, seconded by Supervisor Washington, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, September 25, 2018, be adjourned in memory of Robert "Bob" Presley, a 93-year-old resident of Folsom, California and former resident of Riverside, California who passed away on September 22, 2018.

Born on December 4, 1924 in Oklahoma, Robert had a distinguished career, first as a highly decorated soldier of World War II, then in law enforcement. He was a graduate of the FBI National Academy in Washington D.C. and held a lifetime teaching credential in Police Science. He was also a California State Senator and was active in the California Criminal Justice System. As a combat veteran, Robert was awarded the Bronze Star for Heroic Achievement in Action while serving with the Fifth Army in Italy. He served 24 years with the Riverside County Sheriff's Department, the last 12 years as Undersheriff. He served in the State Senate from 1974 to 1994.

A self-described moderate democrat, Robert was well-respected on both sides. Some of his greatest legislative work included his efforts on environmental protection and air quality, prison reforms and expansion, and domestic violence prevention. He served on many committees including the Judiciary, Agriculture and Water, Natural Resources, and Budget Committees. He also served on the Senate Appropriations Committee, Joint Legislative Audit Committee, Senate Select Committee on California's Business Climate, Senate Select Committee on Children and Youth, Joint Legislative Prisons Committee, and was a leading advocate of streamlining government.

Robert received numerous awards and accolades by state and county leaders. Both the County jail and courthouse in Riverside are named in his honor. In a survey of the Capitol Press Corp, Legislators, legislative staff, and governmental advocates, the California Journal rated Robert number one out of 40 State Senators. The National Assembly of Governmental Employees also selected him as one of ten outstanding State Legislators in the United States. Groups such as the California Peace Officers' Association, the State Parks and Recreation Association, the County Supervisors Association of California, the Family Services Council of California, and the Chief Probation Officer of California named him "Legislator of the Year."

Robert will always be remembered as a legend who did the right things for the right reasons. He placed service to all above self and leaves behind a legacy few Californians will ever equal or surpass. His memory and passionate spirit will live forever in the hearts of those who knew and loved him.
