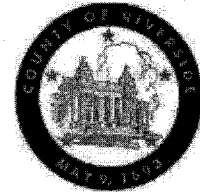



**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. Green Acres Interactive Therapy - \$2,500 will be utilized to serve the special needs individuals by providing physical and emotional therapy on horseback and outdoor activities.
2. Rose Again Foundation - \$2,000 the funding will be used to provide educational tutoring for foster youth in the Southwest region.
3. Rotary Club of Murrieta - \$3,500 the funding will support the Murrieta Field of Honor events held every year to acknowledge and thank local veterans in the Murrieta area.
4. The Love Song Foundation - \$2,500 the funding will provide customized crisis kits for patients receiving treatment for a terminal illness in the Southwest area of Riverside County.
5. San Jacinto Chamber of Commerce - \$1,500 the funding will be used for the Candy Corner event in which provides a safe alternative to street "trick or treating" for the San Jacinto Valley's children.
