**Summary**

As authorized by the Violence Against Women Act (VAWA) of 1994, the Department of Justice's Office on Violence Against Women (OVW) administers several grant programs intended to combat violent crimes against women, including the Services\*Training\*Officers\*Prosecutors (STOP) Formula Grant Program. The VOCA Formula Grant Program is authorized by the Victims of Crime Act of 1984 and provides federal financial assistance for crime victim assistance programs that meet certain requirements. Specifically, these grants are used to fund the Victim/Witness (V/W) Assistance Program, as administered throughout California's 58 counties, including the Office of the District Attorney for the County of Riverside.

The Office of the District Attorney's Victim/Witness Assistance Program is designed to provide comprehensive services to assist victims and witnesses of all types of violent crime. The services include crisis intervention, emergency assistance, resource and referral assistance, direct counseling, victim of crime claims, property return, orientation to the criminal justice system, court escort, training for criminal justice agencies, public presentations, case status/disposition, notification of family, friends, and employees, and restitution.

In addition to the services listed above, Advocates assigned to the grant will conduct field visits when necessary; educate, recruit and use volunteers; assess the needs of disabled and home bound victims in order to provide services; provide translation and interpreter services; encourage referrals from law enforcement and community-based organizations; and maintain a formal system of networking and coordination with other agencies.

Approximately \$5.8 million is available for fiscal-year 2018-19, with the STOP Formula Grant Program requiring a 25% cash or in-kind match and the VOCA Formula Grant Program requiring a 20% in-kind match on the part of each awarded sub recipient. The Grant award performance period is 12 months, beginning October 1, 2018 and ending September 30, 2019.

Award documents will be submitted to the Board for approval when the grant funds are awarded. Upon final award, the financial data portion of this form will be completed.

County Counsel has reviewed and approved the Certification of Assurance of Compliance (VAWA/VOCA Cal OES 2-104h) as to form.

**Impact on Residents and Businesses**



This information on the activities supported by the award funding will assist in assessing the effects that VOCA Victim Assistance funds have had on services to crime victims within the jurisdiction.

19. Access to Records

The Subrecipient authorizes the Office for Victims of Crime (OVC) and/or the Office of the Chief Financial Officer (OCFO), and its representatives, access to and the right to examine all records, books, paper or documents related to the VOCA grant.


