



**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. Eventscape International, Inc will be hosting the 6th Annual Run with Los Muertos and the first Oaxaca Cultural Exchange. This event collaborates with dozens of local agencies to provide art, culture, health, and educational opportunities that celebrate the day of the dead holiday. CID funds will be utilized on equipment and supplies for the build out of Run with Los Muertos and cultural exchange events.
2. The 4<sup>th</sup> Annual Official Latino Short Film Festival will take place in the City of Coachella on October 11-14, 2018. The film festival promotes and supports the emerging Latino and Diverse filmmakers in the United States. This year local artist from the Coachella Valley are invited to participate with an art contest. EDA will utilize CID funds to help cover the cost of materials for painting, and cover the local performer's fees and equipment.
3. The Riverside National Cemetery Support Committee (RNCSC) provide financial support and assistance in the maintenance, operation, and beautification of Riverside National Cemetery. RNCSC also provide services for veterans, military families and friends such as the Remembrance of Love Project, and providing the Indigent Unclaimed Veterans Ceremony. CID funds will be utilized towards the purchase of a Medium Range Stone Burier Excavator for burial site preparation.
