BACKGROUND:

Summary

The Board received a recommendation on October 2, 2018, Agenda Item 3.15, that a salary adjustment of approximately 8.5% be granted to the District Attorney based upon an original proposal brought forth to the Board in 2014 benchmarking the District Attorney to the Sheriff/Coroner/Public Administrator.

On August 5, 2014, Agenda Item 3.21, the Human Resources Department submitted Ordinance No. 781.14 which included benchmarking the District Attorney to the Sheriff/Coroner/Public Administrator at a proposed salary amount of \$273,000. The initial introduction to the Board was approved with reductions to proposed salaries of all elected officials including the District Attorney.

On September 9, 2014, Agenda Item 3.65, the Human Resources Department submitted Ordinance No. 781.14, to Establish Compensation and Benefits for Elected Officials other than Members of the Board of Supervisors. The District Attorney's salary was set at \$247,024 and by July 8, 2015, another increase was approved that would set the District Attorney's salary to \$251,964. The salary has remained consistent since 2015, allowing for a \$1,020 wage gap between the District Attorney and the Chief Assistant District Attorney. The Human Resources Department is now requesting an adjustment to the District Attorney's salary to \$273,463, benchmarking to the Sheriff/Coroner/Public Administrator as originally proposed to the Board in 2014.

Salary Adjustment

It is recommended to grant this classification a parity adjustment from salary plan/grade ELO 115/L1 (\$251,964) to salary plan/grade ELO 116/L1 (\$273,463) in order to restore the internal parity relationship between the Chief Assistant District Attorney and the District Attorney classifications.

The District Attorney is the public prosecutor, vested with the power and duty to investigate, gather evidence, initiate, and conduct prosecutions on behalf of the people. The fourth largest in the state, the Riverside County District Attorney's Office accomplishes its public safety mandate


