#### **BACKGROUND:**

The Governor and legislature have reallocated two (2) vacant judgeships from the Superior Courts of Santa Clara to the Superior Courts of Riverside. Riverside Superior Court Appointments were made in February 2018 and June 2018. In order to provide continuity of security two (2) additional Deputies are now required. The state has allocated \$140,000 in Trial Court Funding to reimburse the County for this expense.

Per Government Code 69926(b) and the Memorandum of Understanding (MOU) between the County of Riverside and the Superior Court of California, the Sheriff shall provide Court Security Services to the Court.

#### **Impact on Citizens and Businesses**

Courthouses must be accessible and in centralized locations. Due to this, it is imperative that Courts must have proper security to ensure public safety. All costs for this service will be fully recovered through Trial Court Funding.
