



**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. Trauma Intervention Programs of Southwest Riverside County - \$1,000 the funding will be used to recognize and honor heroes of Law Enforcement, Fire Fighters and volunteers who respond to emergencies.
2. Mountain Communities Fire Safe Council - \$4,000 the funding will be utilized to pay for the cost share to help low-income, senior and disabled homeowners to reduce hazardous fuels from properties in the mountain communities.
3. Community Outreach Ministry - \$1,000 the funding will be used to provide low-income children with a holiday celebration in which the children receive food and clothing supplies.
4. Assistance League of Hemacinto - \$3,000 the funding will be used for Operation School Bell in the Hemet / San Jacinto area where children receive new school appropriate clothing.
