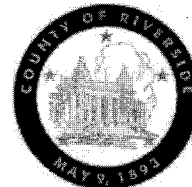

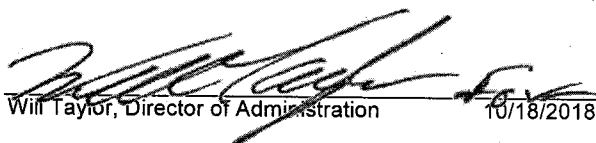
SUBJECT: SHERIFF-CORONER-PA: Approval of Grant Cooperative Agreement Document (OJP 4000/2) with the U.S. Department of Justice, Office of Justice Program, Bureau of Justice Statistics, FY18 NCS-X Implementation Assistance Program: Support for Local Law Enforcement Agencies, Part 1, Grant; to Accept the Grant Award 2018-FU-CX-K011 and Authorization of the Board Chairman to Sign the Grant Cooperative Agreement, All Districts. Total Project Cost \$1,524,997 [\$1,524,997 – Federal Grant Revenue 100%], 4/5 vote.

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve the Grant Award Cooperative Agreement (OJP Form 4000/2) with the U.S. Department of Justice (DOJ), Office of Justice Programs (OJP), Bureau of Justice Statistics (BJS) FY18 NCS-X Implementation Assistance Program: Support for Local Law Enforcement Agencies, Part 1, Grant to accept the award, and authorize the Chairman of the Board to sign the Cooperative Agreement on behalf of the County;
2. Authorize the Sheriff or his designee to sign and submit grant payment requests and progress reports, and execute amendments and/or modifications that do not increase the total award by more than 20% for the FY18 NCS-X Implementation Assistance Program: Support for Local Law Enforcement Agencies, Part 1, Grant on behalf of the County, based on the availability of fiscal funding and as approved by County Counsel; and
3. Approve and direct the Auditor-Controller to make the budget adjustments on the attached Schedule A.

BACKGROUND:

Summary

On May 8, 2018 (Board agenda item no 3.18), the Board of Supervisors approved and authorized the Chairman to sign grant application related documents to support the County's application for the FY18 NCS-X Implementation Assistance Program: Support for Local Law Enforcement Agencies, Part 1, Grant. As a result, on September 25, 2018, the County of Riverside was awarded \$1,524,997 to purchase grant funded computer hardware and infrastructure to assist in bringing the County's CAD/RMS systems into compliance with the National Incident-Based Reporting System (NIBRS) prior to the NIBRS transition deadline of January 1, 2021.

The FBI's Criminal Justice Information Services (CJIS) Division established and maintains the National Incident-Based Reporting System (NIBRS). To generate detailed national estimates of crime known to law enforcement (LE) using NIBRS data, the Bureau of Justice Statistics (BJS) and the FBI are supporting the National Crime Statistics Exchange (NCS-X) Initiative. To produce statistically sound national estimates of crime, the NCS-X program will support the transition to NIBRS reporting of a scientifically selected sample of 400 LE agencies nationwide. BJS sought proposals to enable up to 173 local LE agencies in the NCS-X sample to report incident-based crime data to the FBI's NIBRS, either through their state Uniform Crime Reporting (UCR) Program or directly to the FBI. These local LE agencies are currently not reporting incident-based data to the NIBRS Program. BJS funding decisions under this grant solicitation were made in coordination with, and with the concurrence of, the FBI's CJIS Division. This is the first year that the County of Riverside was offered this type of grant funding and it is the last year that such funding will be offered since this grant project will end by the NIBRS transition deadline of January 1, 2021.

The FBI formally announced its intention to establish NIBRS as the UCR crime data reporting standard for the nation, with a corresponding plan to retire the Summary Reporting System of the UCR Program. The NCS-X seeks to expand the FBI's NIBRS into a nationally representative system of incident-based crime statistics. BJS and the FBI have partnered together to implement the NCS-X project. The NCS-X aims to enroll a sample of 400 scientifically selected LE agencies to submit data to NIBRS. When data from these 400 new NIBRS-reporting agencies are combined with data from the more than 6,800 agencies that

already report to NIBRS, the nation will be able to generate nationally representative incident-based crime statistics drawn from the operational data systems of local police departments. These incident-based data will capture the attributes and circumstances of criminal incidents and allow for more detailed and transparent descriptions of crime.

The sample-based approach to enrolling new NIBRS reporting agencies will enable the production of national estimates of crime based on incident-based data, while the FBI transitions NIBRS to the system to which all U.S. LE agencies submit their UCR data. The Riverside County Sheriff's Department is one of the 400 local LE agencies selected to participate in the two-year transition project to submit data to NIBRS. The County's NCS-X two-year project will begin on December 1, 2018 through November 30, 2020 and will be completed prior to the January 1, 2021 transition deadline. The Sheriff's Department along with the other participating local LE agencies will transition to incident-based reporting (IBR) that also requires each agency to work closely with their state UCR Program to ensure submitted data meet the requirements of their state programs.

California does not currently have a NIBRS-certified UCR Program, however, they are working on a state-level transition to NIBRS by the January 1, 2021 deadline for the NIBRS transition.

The Sheriff's Department's current records management system (RMS) is not NIBRS capable or compliant. The County, on behalf of the Sheriff's Department, applied for \$1,524,997 of grant funding and was fully funded through the BJS FY18 NCS-X Implementation Assistance Program: Support for Local Law Enforcement Agencies, Part 1 Grant to purchase computer hardware and infrastructure associated with this project. The grant project will consist of researching a RMS solution that will generate the required data elements to support state-specific and be NIBRS-compliant for incident-based reporting. The Sheriff's Department is in process for a new CAD/RMS solution that will be NIBRS compliant.

County Counsel has reviewed and approved the Cooperative Agreement as to form.

Impact on Residents and Businesses

The BJS FY18 NCS-X Implementation Assistance Program: Support for Local Law Enforcement Agencies, Part 1 Grant funding will assist the County in becoming NIBRS compliant which is a requirement by January 1, 2021. Becoming NIBRS compliant will assist the County and its residents by obtaining more accurate and complete crime statistics. We currently utilize Uniform Crime Reporting (UCR) and it only captures summary-based statistics where as NIBRS captures incident-based statistics. This paradigm shift in data collection will give a clearer picture of actual crime incidents and allow for better allocation of resources

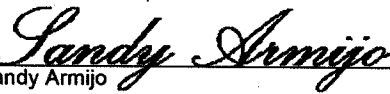

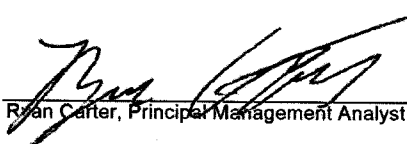

1. Requirements of the award; remedies for non-compliance or for materially false statements

The conditions of this award are material requirements of the award. Compliance with any certifications or assurances submitted by or on behalf of the recipient that relate to conduct during the period of performance also is a material requirement of this award.

Failure to comply with any one or more of these award requirements -- whether a condition set out in full below, a condition incorporated by reference below, or a certification or assurance related to conduct during the award period -- may result in the Office of Justice Programs ("OJP") taking appropriate action with respect to the recipient and the award. Among other things, the OJP may withhold award funds, disallow costs, or suspend or terminate the award. The Department of Justice ("DOJ"), including OJP, also may take other legal action as appropriate.

Any materially false, fictitious, or fraudulent statement to the federal government related to this award (or concealment or omission of a material fact) may be the subject of criminal prosecution (including under 18 U.S.C. 1001 and/or 1621, and/or 34 U.S.C. 10271-10273), and also may lead to imposition of civil penalties and administrative remedies for false claims or otherwise (including under 31 U.S.C. 3729-3730 and 3801-3812).

3. Compliance with DOJ Grants Financial Guide

References to the DOJ Grants Financial Guide are to the DOJ Grants Financial Guide as posted on the OJP website (currently, the "DOJ Grants Financial Guide" available at <https://ojp.gov/financialguide/DOJ/index.htm>), including any updated version that may be posted during the period of performance. The recipient agrees to comply with the DOJ Grants Financial Guide.

4. Reclassification of various statutory provisions to a new Title 34 of the United States Code

On September 1, 2017, various statutory provisions previously codified elsewhere in the U.S. Code were editorially reclassified to a new Title 34, entitled "Crime Control and Law Enforcement." The reclassification encompassed a number of statutory provisions pertinent to OJP awards (that is, OJP grants and cooperative agreements), including many provisions previously codified in Title 42 of the U.S. Code.

7. Requirement to report potentially duplicative funding

16. Effect of failure to address audit issues

The National Crime Statistics Exchange (NCS-X) is an effort to expand the FBI's National Incident-Based Reporting System (NIBRS) into a nationally representative system of incident-based crime statistics. BJS and the FBI are implementing NCS-X with the support of other Department of Justice agencies, including the Office for Victims of Crime. The goal of NCS-X is to enroll a sample of 400 scientifically selected law enforcement agencies to submit data to NIBRS; when these 400 new NIBRS-reporting agencies are combined with the more than 6,600 agencies that currently report to NIBRS, the nation will have a nationally representative system of incident-based crime statistics drawn from the operational data systems of local police departments. These incident-based data will draw upon the attributes and circumstances of criminal incidents and allow for more detailed and transparent descriptions of crime in communities. The current mechanism by which local law enforcement (LE) agencies report data to the FBI's NIBRS, in general, is for local LE agencies to submit data to their state UCR reporting program, and then for the state UCR program to report those data to the FBI. While the FBI does accept NIBRS data directly from a small number of law enforcement agencies, the highly preferred route of reporting is through the state UCR program. The FY2018 solicitation furthers the goals of the NCS-X initiative

by providing funding to the remaining states and local agencies in the NCS-X sample in order to assist them transition to NIBRS reporting.

Riverside County Sheriff's Department (RCSD) is located in the 4th largest county in California, covering more than 7,300 square miles and policing 17 of the 28 cities in Riverside County. Riverside County has an estimated population of 2.4 million residents.

Currently, the agency utilizes an antiquated system that is unable to meet the required NIBRS standards. The department does not even utilize an electronic report writing system; therefore, all data are entered manually into their record management system (RMS). RCSD is going through the competitive process for procuring a new integrated computer aided dispatch and RMS (CAD/RMS) that will be NIBRS compliant. The selected vendor is slated to provide a mobile report writing module that will integrate the CAD data with the RMS data and provide an automated tool for patrol personnel to collect incident information. RCSD is requesting funds for the NIBRS component of the new RMS (based on quotes received through their competitive procurement process) and for hardware to support the new system.
