BACKGROUND:

Summary

Since 1989, Riverside University Health System—Foundation has operated as a 501C3 organization, dedicated to raising financial support for programs, education and equipment purchases for Riverside University Health System. RUHS Foundation continues to grow and evolve as a robust philanthropic organization, focused on supporting the mission and work of a high-quality, integrated health and behavioral health system. In the past two years, the Foundation has made a significant shift to working with individual donors and grantors, rather than focusing primarily on event-based fundraising. Support from community, donors, and friends allowed RUHS Foundation to achieve some major milestones this past year including:

- The largest gift from an individual in the organization's history
- Multiple gifts that each exceeded \$100,000
- The most profitable Festival of Trees yet, and the single largest sponsorship in the event's history
- The Foundation wrote its largest check to date to RUHS Medical Center: \$1.1 Million to fund the Cardiac Cath Lab and an additional \$139,000 for other related equipment

Impact on Residents and Businesses

Providing funding for lifesaving and diagnostic equipment to RUHS Medical Center improves healthcare outcomes, safety and the experience of thousands of patients annually, and elevates the quality of local healthcare. RUHS Medical Center serves hundreds of thousands of patients annually. The hospital is home to the only pediatric intensive care unit in the County of Riverside. The Medical Center houses a busy level 2 trauma center and emergency department, serving almost 90,000 emergency and trauma patients annually.
