BACKGROUND:

Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports economic expansion and the development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the WDB's members must come from the business community. In addition, WDBs are required to have representation from universities or community colleges and other training providers, as well as economic development and workforce program leaders. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official (CLEO), is responsible for appointing the WDB members for two year terms.

Mr. Ron Vito, Executive Director, Riverside County Office of Education (RCOE) has been a long time educator. Mr. Vito has a Masters of Education Administration from

California State University, San Bernardino and a Bachelors of Science in Business Administration. He has served in various capacities within RCOE Career Technical Education (CTE) as well as Riverside City College (RCC). Mr. Vito has been recognized with the Management Achievement Award from the RCC District twice as well as the Administrator of the Year Award. Based on his in-depth knowledge of CTE at the local, regional and state level, he brings a wealth of experience to the WDB. As one of the education partners, he brings to the table insight on the training component of workforce development and the needs of business and industry.

Mr. Vito has expressed interest in continuing to serve on the WDB as an Educational Representative for All Districts. If approved he will serve a two year term, commencing October 2, 2018 and expiring October 2, 2020.
