**BACKGROUND:**

**Summary**

On January 28, 2014, Item 3-11, the Board of Supervisors (Board) authorized the Economic Development Agency (EDA) to apply for funding from the California Energy Commission (CEC) EV Infrastructure Grant (PON 13-606) and to identify match funds and in-kind matching resources as required by the grant. On April 4, 2014, EDA received a Notice of Proposed Award from the CEC for \$497,357 with the county's required match portion from the EDA Energy Management Budget. On July 15, 2014, Item 3-21, the Board formally accepted grant funds and terms from the CEC in the amount of \$497,357.

EDA's proposal consisted of the installation of a total of 45 EV charging stations at 27 Riverside county-owned sites across the entire county region. The proposed distribution of the charging locations were along major freeway corridors (15%), at destinations sites (18%) and at workplace sites (67%).

On March 1, 2016, Item 3-12, the Board approved the construction contract for Job Order Contract No. 007 between the County of Riverside (County) and Angeles. Pursuant to the contract, a job order was issued in the amount of \$235,678 for the construction and installation portion of 33 EV charging stations at 23 county-owned sites.

Angeles has completed the work, and the project has been inspected and found to comply with the contract requirements. This Board action will release the undisputed contract retention funds in the amount of \$11,784 to Angeles after the Notice of Completion has been recorded and the 35 day lien period has expired per contract terms. The 33 completed EV charging stations are listed on Attachment A. EDA will return to the Board to record a Notice of Completion for the remainder of the charging stations and locations.
