At a young age, Dr. Shafai expressed his desire to become a physician. After obtaining his Medical Degree at the University of Tehran, he moved to the United States to further his education. Arriving in Washington DC in 1963, he went on to receive his PhD in Biochemistry from Georgetown University in 1969. After completing his residency in Syracuse, New York, he moved to Buffalo, New York, working at the Oishei Children's Hospital.

Ultimately, Dr. Shafai moved to Riverside with his family to take over as Chief of Pediatrics at Riverside General Hospital. He later entered private practice and continued to provide care at local hospitals. He established the Children's Medical Group in order to deliver the highest level of medical care for children in the Inland Empire. Dr. Shafai believed every child should be afforded high quality health care and never turned away a patient. He provided support to numerous organizations in Riverside for at-risk children and assisted governmental agencies and nonprofit organizations including First 5 Riverside.

An inspirational force in the community, Dr. Shafai was a pioneer in expanding medical care in Riverside, helping to nurture and teach new doctors in the area and assisting with the establishment of UCR Medical School. As part of the clinical faculty of UCR Medical School, he opened his medical practice to numerous students, hoping they would practice medicine in the Riverside area. He was also a dedicated advocate of breastfeeding, serving as chair on the American Academy of Pediatrics Committee on Breastfeeding.

Dr. Shafai was a loving and devoted husband, father, grandfather, mentor, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.
