**SUMMARY OF PROPOSED ORDINANCE NO. 745
(AS AMENDED THROUGH 745.3)**

**ORDINANCE NO. 745
AN ORDINANCE OF THE COUNTY OF RIVERSIDE
PROVIDING FOR THE COMPREHENSIVE COLLECTION AND DISPOSAL OF SOLID
WASTE WITHIN SPECIFIED UNINCORPORATED AREAS OF RIVERSIDE COUNTY.**

This summary is presented pursuant to California Government Code Section 25124(b); a certified copy of the full text of Ordinance No. 745.3 may be examined at the Office of the Clerk of the Board of Supervisors of the County of Riverside located at 4080 Lemon Street, 1st Floor, Riverside, California.

Ordinance No. 745.3 amends Ordinance 745, regulating solid waste collection and disposal in the unincorporated areas of Riverside County. The ordinance includes the requirements for comprehensive collection of solid waste, the terms to exempt comprehensive service, and the process for placing assessments to property for unpaid solid waste services.

Ordinance 745 is being amended to remove outdated language that is now superseded by the County's franchise waste agreements, revise the process to address and assess property for unpaid solid waste services to be consistent with County Assessor policies and incorporate waste residential and commercial solid waste rules from Ordinance 657 to consolidate solid waste regulation into one Ordinance and to reorganize and clean-up Ordinance language to make the ordinance easier to understand.
