BACKGROUND:

Summary

At the Board meeting August 25, 2015, item 3.35, the Board voted to reinstate the RIDE program. The RIDE program provides transportation to inmates to take them home after their release. The continuance of this program would maintain the safety of the community surrounding the Cois Byrd Detention Center.

The Sheriff reports that \$92,633 was spent to provide taxi services between July 1, 2017 and June 30, 2018 related to the RIDE program. In order to ensure that the Sheriff has sufficient support to rapidly deploy the program we request that the Board approve this item and authorize a budget transfer of the full cost of one year, \$100,000.

Last year the Sheriff released 6,679 inmates from the Cois Byrd Detention Center during the hours of the transportation operation. Of these 1,976 who were unable to secure transportation were provided a taxi voucher averaging \$46.88 each. We believe providing transportation services and maintaining funding for this program will keep the surrounding community safe. We are committed to ensuring the safety of Third District constituents.

Impact on Residents and Businesses

Third District constituents living near the Cois Byrd Detention Center have benefitted from knowing that the transportation effort was in place. Continuing the effort provides released inmates with a ride home and gives the community a greater sense of safety.
