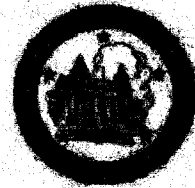



BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Diabetes Camping & Educational Services - \$2,500 the funds will be used for the Domenigoni Ranch Charity Ride for Diabetes, which is a fundraiser to pay for research, education and camp for children who have diabetes.
2. Kids Court & Counseling Center - \$2,500 the funding will be utilized for counseling services for children in foster care who are in need of counseling to decrease children's apprehension and anxiety when testifying in court.
3. NAMI Mt. San Jacinto for NAMI Walks Inland Empire - \$1,500 the funding will be used to support the 13th annual NAMI Walk fundraiser for community outreach for residents and family members who are impacted by mental illness.
