

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Santa Rosa Plateau Nature Education Foundation - \$1,000 the funding will be used for transportation costs for students to take part in field study sites located at the Santa Rosa Plateau Reserve.
2. The Diamond Valley Arts Council - \$1,500 the funding will be utilized for the Art for Youth Competition in which high school students in the San Jacinto Valley are able to showcase their art works properly prepared for gallery presentation.
3. California Inland Empire Council, Boy Scouts of America - \$2,500 the funding will be used for camp scholarships for campers that need financial support to attend camp.
