BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. Angel View, Inc. is a non-profit organization supporting a wide range of services to children and adults with disabilities to help them reach their maximum potential. These services includes residential nursing care, therapeutic day programs and family stabilization case management. CID funds will be used to help offset fees paid to Old Town Artisan Studios and Susan Lake for providing Art Therapy to clients of Angel View's Day Program (art and dance).
- 2. The Cathedral City Senior Center will be hosting a Cinco de Mayo event in collaboration with Rotary Clubs, Interact Clubs and Cathedral City High School. This event will help fundraise, raise the visibility of the senior center and will bring together a diverse group of people. CID funds will help cover the cost of drinks, appetizers, dinner and décor.

- 3. The Joslyn Center provides health, recreational, educational and social programs along with information, referral volunteer and support services for adults age 50 and older. The Arthur Newman Theater has provided the Joslyn Center with a place to present entertainment, music, plays, and educational programming. CID funding will help cover the cost of professional and programmable digital theater lighting control board, sound mixer, and amplifier with speakers.
- 4. The Coachella Valley Historical Society's mission is to preserve, interpret, and share artifacts that create a dialogue about the evolving history of the Coachella Valley. The museum offers different programs including; free tours for 3rd grade students in the Indio area, Summer Art Camps, monthly Cultural Chats, nationally recognized Junior Historian program, Dia de Los Muertos Celebration and more. The CID funds will be used to help with the cost of a new exhibit and programming of the FINK Mexican Folk Art Collection.
- 5. Red Hot Ballroom, Inc. is a non-profit after-school program providing students the opportunity to participate in dance instruction. This program is provided on site at 34 public schools in all three school districts: Coachella Valley Unified School District, Desert Sands Unified School District, and Palm Springs Unified School District. The dance program teaches social skills, self-esteem, respect for others and healthy physical exercise. At the end of the school year Red Hot Ballroom holds a dance competition among school districts. CID funds will be utilized toward the fee of the professional Youth Band, Heatwave Jazz and Show Band which will perform at all three Dance Competition Finals.
- 6. Coachella Valley Community Trust (CVCT) mission is to foster productive and responsible young people through effective community collaborations. CVCT offers an after school Kids Club. CID funds will be used for Mini-Grant Program, which provides low-income atrisk youth the opportunity to participate in extracurricular activities, field trips, classes and other educational opportunities families can't afford.
- 7. The Riverside Medical Charitable Foundation hosted their 4th Annual Bullying Prevention Conference on November 5, 2018. This event holds dynamic speakers that educate attendees on the latest information and strategies to combat bullying. Resources and solutions are given to reduce bullying and cyber bullying in schools and community centers, and to help promote positivity and empathy to make children happier, kinder and more successful. The CID funds will help provide free admissions and any revenues from this event will be used to fund their HERO program.
- 8. Voices for Children provides a Court Appointed Special Advocate (CASA) for foster children in Riverside County. CASA advocates for the rights and well-being of children, from newborn to 21 years, and provides support that they need to thrive in life. CID funding will be used to recruit, train and manage CASA volunteers providing advocacy for three foster children living in the Fourth District.
- 9. Rotary is an international organization with clubs around the world, its members' main objective is to serve their communities through their personal, business and community life. Indio Rotary is hosting it's Annual Rotary Math Field Day, which provides middle school students with an opportunity to participate in a math competition. CID funds will be used to purchase awards, including trophies, ribbons, and prizes for winners.

- 10. The Health Assessment and Research for Communities (HARC) mission is to provide objective reliable research, analysis and technical service of health needs to the Coachella Valley. HARC conducts a community-wide survey of the health and well-being topics, such as health access, utilization, behaviors, major disease, mental health, and more. Results are provided to the community at no charge. CID funding will help enable to retain questions about veterans.
- 11. The Navy League Greater Palm Springs Council dedicate to educating the citizens about the importance of sea power and supporting the members of the sea services and their families, to help build America's future through successful youth programs like the Naval Seal Cadets corps and Desert Hot Springs Marine Corps JROTC. The Council hosted the 1st Annual Coachella Valley Veterans & Guest Holiday Party. CID funds will help cover the cost of the food.
- 12. The Coachella Valley Horse Rescue launched the Horsinalities Veterans Boot Camp in 2017 as a 4 week pilot program, in an effort to help veterans and horses regain their inner strength, confidence, and trust while going through obstacle courses and participating in various drills and exercises led by a certified horse professional. The CID funds will help cover the costs of 2 veterans twice a week for 6 months.
- 13. The purpose of the Riverside National Cemetery Memorial Honor Detail is to render military honors for veterans who are buried at the RNC. All services will be rendered free of charge, using volunteers. CID funds will be used to help cover the costs of flags of each branch of the military service for use at the ceremonies, patches/ribbons, team plaques.
- 14. Coachella Valley Rescue Mission provides food, shelter, clothing, counseling, and case management services for individuals who are homeless and displaced. CVRM Emergency Services program operates 24 hours a day which includes overnight shelters. CID funds will be utilized towards their Emergency Services for Homeless Veterans program which will help shelter 5 veterans.
- 15. Sage Initiative CARES Dental program provides free comprehensive dental treatment, which includes emergency, preventative, and restorative dental treatment. Dental services include but not limited to bridges, fillings, crowns, extractions, cleanings, and dentures. CID funds will be used to offset the cost of treatment for veterans, as well to purchase dental supplies and materials used on opertations.
- 16. The American Outreach Foundation is a non-profit organization that provides electric wheelchairs and scooters, in perfect condition to veterans, low-income seniors and those who do not have insurance or those whose health insurance policy does not cover this type of assistance. CID funds will be utilized to help cover the cost of pickup/ delivery of power chairs, batteries and other program costs.

- 17. Community Improvement Designation funds will be allocated to the Economic Development Agency (EDA) Youth Protection Fund. The CID funds will be used to assist with the purchase of food; this will include breakfast, lunch and all refreshments for every attendee of the 2019 Youth summit. Attendance is free for high school students in Riverside County.
- 18. The Regional Access Project (RAP) Foundation serves as the fiscal agent for the scholarship fund for the Fourth District Youth Advisory Council (YAC). YAC members are high school students who participate in monthly community and county service projects in the Fourth District. CID funds will go to the RAP foundation to support the scholarship fund.
- 19. The Palo Verde Cemetery District maintains a developed cemetery site of 18 acres. PVCD relies on service fees and property taxes for its funding. It has also been able to operate with a dedicated group of volunteers. CID funds will be used to help cover the remaining balance of 2017/18 tree maintenance expense (Refer to board agenda item 3.6 March 13, 2018)
