#### **BACKGROUND:**

### **Summary**

On July 17, 2018, the Board approved the contract documents for the construction of a FMF at the LCL and authorized the Department of Waste Resources (Department) to advertise for bids (MT #7446). On August 29, 2018, the Department opened bids and received a total of six (6) bid proposals, with PCN3 submitting the lowest apparent bid in the amount of \$2,148,414, which is substantially higher than the engineer's estimate for this project (a summary of the bid result is attached herewith). All bid proposals were subjected to review by Department and County Counsel staff for compliance with the bid requirements.

After careful review of the bid result, the bid proposal from PCN3 has been deemed as non-responsive based on several factors, most notably include the following: 1) the bid did not include documentation to establish the bidder qualifications as required by the Contract Documents, 2) project references provided did not meet the required experience qualifications; and, 3) some of the contacted project references provided unfavorable information regarding their work experience with PCN3. These irregularities were deemed as sufficient to reject the bid proposal by PCN3.

Consequently, the Department has issued a bid rejection letter to PCN3, which resulted in a bid protest submitted by PCN3. The bid protest including all supplemental information provided by PCN3 were reviewed and evaluated by the Department's General Manager-Chief Engineer and County Counsel staff who concluded that PCN3's assertions and contentions were unfounded and, therefore, the bid protest was denied.

Upon reviewing all submitted bid proposals, the Department has determined that it is in the best interest of the County to not move forward at this time with an award due, in part, to the current market conditions for steel material causing bid proposals to substantially exceed the allocated project budget (the structural steel price reached an all-time high in September 2018). Based on this determination, the Department recommends that the Board of Supervisors reject all bids received on August 29, 2018 for the construction of the FMF at the LCL. It is anticipated that this project will be re-advertised at a later date.

### California Environmental Quality Act (CEQA) Findings

Since the proposed motion simply involves the rejection of all bids received for the construction of a FMF at the LCL, this action is exempt under CEQA per Section 15061(a)(4).

### **Impact on Residents and Businesses**

Future consideration of this project will ensure compliance of fleet activities with the applicable regulations, and will augment Department's on-going efforts to reduce the introduction of pollutants which affect the quality of storm water discharges associated with landfill operations at the LCL.

# **Additional Fiscal Information**

No expenses will be incurred as a result of the recommended motion.

# **Contract History and Price Reasonableness**

The Engineer's estimate for this project will be updated to reflect the current market condition and prices for construction material, particularly structural steel. The Department will return to the Board of Supervisors at a later date to seek approval to re-advertise for this project to obtain competitive bids through the California Public Works Contract process.
