### ORDINANCE NO. 657.7 AN ORDINANCE OF THE COUNTY OF RIVERSIDE REPEALING ORDINANCE 657

The Board of Supervisors of the County of Riverside Ordains as Follows:

Section 1. Ordinance No. 657 entitled "Regulating the Collection, Transfer and Removal of Solid Waste" is repealed in its entirety due to the rewrite and consolidation of solid waste oversight into Ordinance 745.3 passed by the Board of Supervisors on December 4, 2018.

Section 2. EFFECTIVE DATE. This ordinance shall take effect thirty (30) days after its adoption.
