

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. Path of Life Ministries - \$47,164** funding will be used to assist with the Homeless Prevention and Mitigation Program. The on-going program helps place homeless clients into permanent housing in the First District. The funding will be used for gap funding for housing costs that HUD does not pay, utility payments, household items, repairs to units, and special needs for clients seeking employment and self-sufficiency. This funding is provided through the BEYOND Framework Fund Program Grant Agreement #17-25-18-02 between WRCOG and the County of Riverside, District 1, in the amount of \$72,164. This is the final distribution to Path of Life Ministries who is the administrator of the homeless Prevention and Mitigation Program for District 1.
