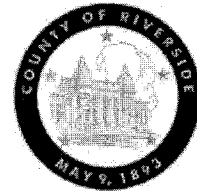





BACKGROUND:
