



BACKGROUND:

Summary

The Transportation Improvement Program (TIP) provides for the construction of the 3rd Place Sidewalk and Roadway Improvements Project from East Vernon Avenue to East 14th Avenue in the Blythe area. 3rd Place is currently a 20 foot wide paved road with sidewalk along the frontage of the Quail Place apartments, south of East 14th Avenue. No pavement, right-of-way, or sidewalk exists along the extension of 3rd Place southerly to the Felix J. Appleby Elementary school at Vernon Avenue. The 3rd Place sidewalk project will construct a sidewalk between East 14th Avenue and the Elementary School to provide for a continuous sidewalk between east 14th Avenue and East Vernon Avenue. The project will also pave a 22 foot half-width road between East 14th Avenue and East Vernon Avenue tying into the existing roadway within the city. Half of 3rd Place is within the City of Blythe.

The scope of work includes constructing sidewalk, curb and gutter, driveways, Americans with Disabilities Act (ADA) compliant curb ramps, asphalt concrete pavement, striping and any other associated work as may be required.

The submitted plans and specifications have been approved as to form by County Counsel.

The bid documents include the following bid schedules of work:

Base Bid Schedule: 3rd Place Sidewalk and associated work.
Alternate Bid Schedule. 1: Utility Adjustments.
Alternate Bid Schedule. 2: 3rd Place Sidewalk Replacement within the City of Blythe's jurisdiction.

The Transportation Department will select the contractor based upon the lowest responsive and responsible bid of the sum of all bid schedules. If the low bid is approved and concurred to by the City of Blythe for their respective alternate bid, then a reimbursement agreement between

the City and County will be prepared and submitted to the Board of Supervisors for approval prior to or concurrent with the award of the construction contract.

Environmental Findings

By minute order dated December 5, 2017 (agenda item 3.21) the Board of Supervisors found the project exempt from the California Environmental Quality Act (CEQA) and filed a Notice of Exemption. Therefore, CEQA compliance has been completed and no further action is required.

Impact on Citizens and Businesses

The project is expected to enhance public health, increase mobility for pedestrians, increase public safety, and reduce greenhouse gases. The construction of a continuous paved roadway and sidewalk on 3rd Place will improve pedestrian and motorists access to Felix J. Appleby Elementary school.

The work is scheduled to begin in July 2019 and will take approximately two months to complete.

SUPPLEMENTAL:

Additional Fiscal Information

The construction contract is estimated to cost approximately \$539,450. Construction is expected to begin and finish in FY 2019/2020 and will be funded with, Gas Tax / HUTA and Active Transportation Plan (ATP) funds for which the Transportation Department successfully competed. The City of Blythe will fund Alternate Bid Schedules 1 and 2 if selected for award.

There are no General Funds used in this project.

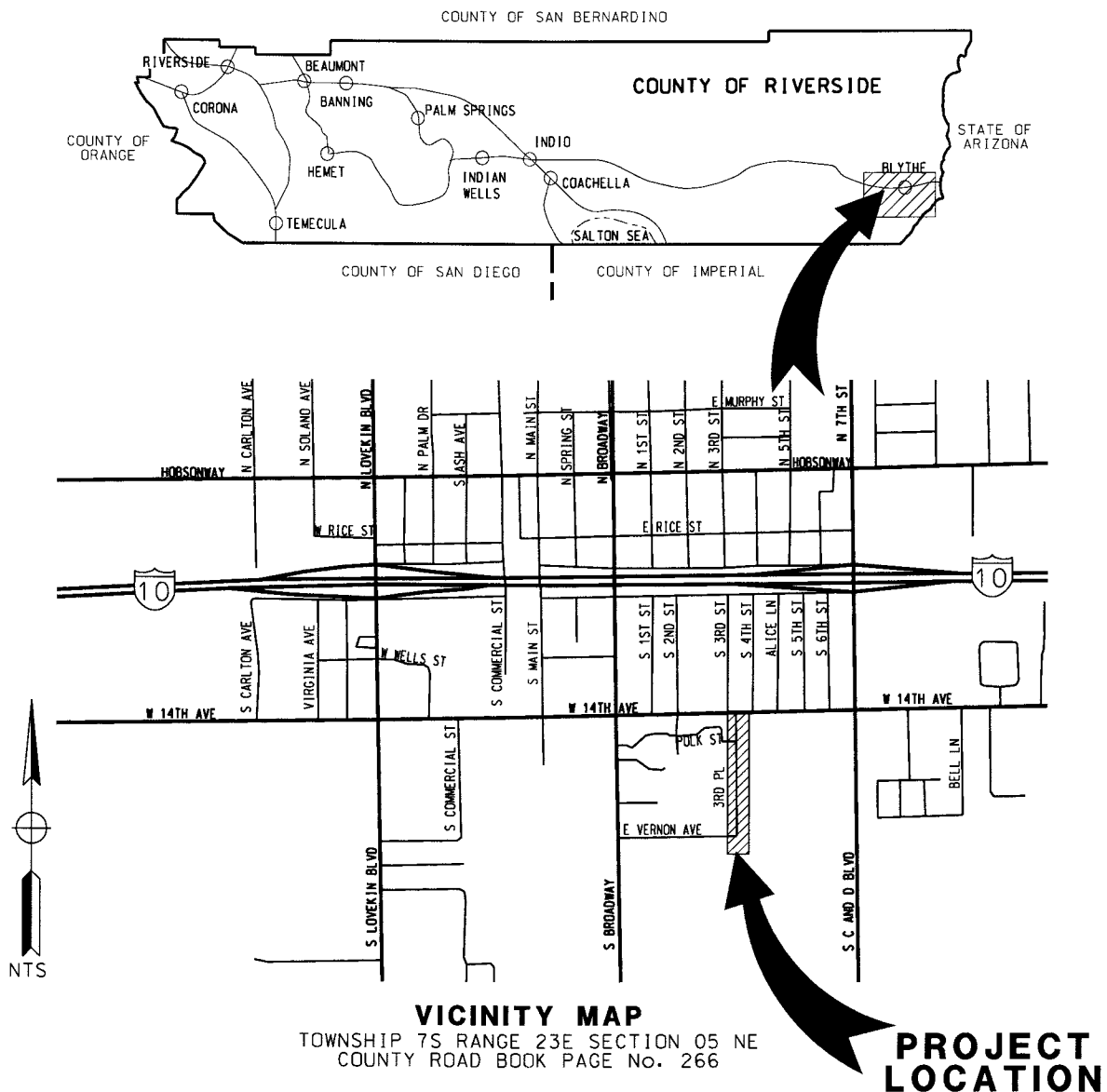

No refund. Prospective bidders may preview the plans, specifications and other contract documents at no charge prior to purchase at the above noted location.

Pursuant to Labor Code section 1771.1, any Contractor bidding, or subcontractor to be listed on a bid proposal subject to Public Contract Code section 4104, shall not be qualified to bid after March 1, 2015, unless currently registered and qualified to perform public works pursuant to Labor Code section 1725.5. No Contractor or subcontractor may be awarded a contract or perform work on any contract for public work, after April 1, 2015, without proof of current registration with the Department of Industrial Relations pursuant to Labor Code section 1725.5 to perform public works.
