#### **BACKGROUND:**

#### <u>Summary</u>

On July 11, 2017, Item 3.23, the Board of Supervisors (Board) approved the RUHS Exit Signs Replacement project to replace the hospitals self-illuminating exit signs that were nearing their end of life use to comply with regulatory requirements. The existing exit signs were replaced in accordance with Office of Statewide Health Planning and Development (OSHPD) and hazardous materials waste disposal regulations.

On March 14, 2017, Item 3.14, the Board approved the construction contract for Job Order Contract No. 008 between the County of Riverside (County) and Angeles. Pursuant to the contract, three job order were issued in the cumulative amount of \$407,852 to complete the Project. During construction it was discovered additional locations required replacement exit signs, 2 supplemental job orders were issued accordingly.

Pursuant to the general conditions of the contract, the Economic Development Agency (EDA) is currently retaining 5% of all progress payments to Angeles. The general conditions of the contract state that after the 50% completion point of the contract work, if satisfactory progress has been made, the County has sole discretion to reduce the retention to a minimum of 2.5% of the contract.

Angeles has completed the work, and the project has been inspected and found to comply with the contract requirements. Upon Board approval, EDA will release \$10,196 of the undisputed retained funds to Angeles, which is 2.5% of the retention withheld; the remaining undisputed retained funds of \$10,197 which is the remaining 2.5%, will be released after the Notice of Completion has been filed and the 35 day lien period has expired per contract terms and applicable law.


