

Born on May 15, 1958 in Pomona, California, Donald lived in Banning since the age of six. He graduated as the Valedictorian from Banning High School in 1976 and from Santa Clara University in 1980. He earned his Juris Doctorate in 1984 from Santa Clara University Law School.

After over a decade of private practice in Palm Springs, Donald began a new journey as a philanthropist and businessman, while maintaining his status as an active and licensed attorney-at-law. He developed and invested in real estate and acted as the Broker of Record for his brother's real estate brokerage, Dan Smith and Associates in Big Bear Lake. He was also a business partner with Maxine Lewis in Haskell Real Estate in Banning.

An instrumental force in the community, Donald will always be remembered for his legacy of public service. He began as a volunteer for the Banning Chamber of Commerce. He was elected as a Banning City Councilman in 1992 and was voted to serve as the Mayor of Banning in 1994. He spent 22 years in service to the County as a member of the Board of Directors for the Riverside County Date Festival, acting as President for three terms. Donald was proud to have been chosen to serve as Vice-Chairman of the 2013 Banning Centennial Celebration. He was also actively involved in numerous organizations including FFA groups, student scholarship funds, and the Banning Cultural Alliance.

Donald is survived by his parents, Ken and Earline Smith; his brothers, Daniel and Kenneth Smith; his five nephews Sawyer, Jonah, Tennyson, Kyle, and Bryan Smith; and his two nieces McKenna and Karen Smith.
