

3. Authorize the Sheriff for the Sheriff's Department, or his designee, to execute any other documents to complete this transaction.



BACKGROUND:

Summary

The City of Moreno Valley would like to donate a 2003 Ford Excursion SUV 4D to the Riverside County Sheriff's Emergency Response Team. This vehicle is no longer used by the City. Once title is transferred, the Riverside County Sheriff's Department will be responsible for the maintenance, repair, and replacement of the vehicle.

This vehicle is a black and white vehicle with approximately 49,000 miles. The City used the vehicle as an Emergency Response Vehicle. The vehicle is already equipped as an Emergency Response Vehicle. The Sheriff's Department would use this vehicle for the Sheriff's Emergency Response Team to carry equipment to Search and Rescue operations, natural disasters and to be utilized in specialized training.

The vehicle is identified as:

2003 Ford Excursion SUV 4D VIN# 1FMNU40S83EC96181

Impact on Residents and Businesses

Accepting the donation of this vehicle from the City of Moreno Valley will benefit the surrounding cities and the unincorporated areas. The vehicle will be used by the Sheriff's Emergency Response Team for Search and Rescue and other operations. The vehicle is 4-wheel drive and can access remote areas, is already equipped as an Emergency Response Vehicle and will be put to immediate use.

15 hundred and seventy-five dollars;

16 NOW, THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED by the Board
17 of Supervisors of the County of Riverside, State of California (the "Board"), in regular session
18 assembled on April 16, 2019, at 9:00 A.M., or soon thereafter in the meeting room of the
19 Board of Supervisors located on the first floor of the County Administrative Center, 4080 Lemon
20 Street, California, authorizes and accepts the donation of the one 2003 Ford Excursion Sport
21 Utility 4D vehicle, in favor of the County.

22 BE IT FURTHER RESOLVED, DETERMINED, AND ORDERED that the County Sheriff
23 or his designee, is authorized to execute any documents to complete this transaction.

24 BE IT FURTHER RESOLVED, DETERMINED, AND ORDERED that a copy hereof by
25 forwarded to the CITY OF MORENO VALLEY as evidence of this authorization and acceptance
26 of the donation.


