

1. Accept as complete Construction of the Fiscal Year 2018/2019 Phase 1 Landfill Gas Header Pipe Replacement at the Highgrove Sanitary Landfill by Aptim Environmental & Infrastructure, Inc., and authorize the Chairman to execute the attached Notice of Completion on behalf of the County;
2. Authorize the release of retained funds to the contractor, Aptim Environmental & Infrastructure, Inc., in the amount of \$5,027.13 for the above referenced construction in accordance with the contract terms and applicable law; and
3. Direct the Clerk of the Board to record the executed Notice of Completion and, upon recordation, return the conformed copies to the Department.

BACKGROUND:

Summary

On March 20, 2018, the Board awarded Aptim Environmental & Infrastructure, Inc., a three-year contract for Construction of Landfill Gas Collection System Components at the Badlands, Highgrove, and Lamb Canyon Sanitary Landfills and as needed Perimeter Probe Installation at all Department Landfills.

Construction of the Fiscal Year 2018/2019 Phase 1 Landfill Gas Header Pipe Replacement at the Highgrove Sanitary Landfill was satisfactorily completed by Aptim Environmental & Infrastructure, Inc. at a cost of \$100,542.50 (Retained Funds of \$5,027.13) and staff therefore recommends approval of the Notice of Completion. The Notice of Completion here is for completed work associated with a Notice to Proceed dated December 13, 2018.

Impact on Residents and Businesses

This contract ensures the Department's ability to efficiently collect the landfill gas generated at the Badlands, Highgrove, and Lamb Canyon Landfills and to monitor the landfill gas migration at all Department Landfills to maintain compliance with air quality regulations.

SUPPLEMENTAL:

Additional Fiscal Information

This is an administrative action to file a Notice of Completion for only the Construction of Fiscal Year 2018/2019 Phase 1 Landfill Gas Header Pipe Replacement at the Highgrove Sanitary Landfill. No funds are being requested.

Under this contract to date, a total of two (2) construction phases have been completed at the Badlands Landfill, two (2) construction phases at the Lamb Canyon Landfill, and one (1) construction phase at the Highgrove Landfill. A cost summary by construction phase and location is summarized below. The total amount of the contract expended to date is \$327,189. The remaining contract amount is \$1,287,106. Department staff recommends authorization by the Board of Supervisors to release the retained funds to the contractor, Aptim Environmental & Infrastructure, Inc., in the amount of \$5,027.13 for the above referenced phase of work in accordance with the contract terms and applicable law.
