ORDINANCE NO. 348.4899 AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE NO. 348 RELATING TO ZONING

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Section 4.1 of Ordinance No. 348, and official Zoning Plan Map No. 2, as amended, are further amended by placing in effect in the French Valley Area, the zone or zones as shown on the map entitled "Change of Official Zoning Plan Amending Ordinance No. 348, Map No. 2.2434, Change of Zone Case No. 1800019" which map is made a part of this ordinance, and establishing the boundaries of the specified planning areas within Specific Plan No. 312, Amendment No. 2

Section 2. This ordinance shall take effect 30 days after its adoption.
