Summary

California Elections Code §§ 10002, 10402, and 10403 allow jurisdictions to request that the Board of Supervisors approve the Registrar of Voters to conduct elections by submitting a resolution requesting these services. The Palo Verde Community College District has complied with this requirement and has requested the Registrar of Voters to conduct its election. The department has the resources to provide these services. The County will receive reimbursements from the jurisdiction based on associated direct costs of conducting their election.

Impact on Residents and Businesses

Registered voters in the Palo Verde Community College District will have the opportunity to vote on a seat on the board of trustees.

Additional Fiscal Information

The County will receive reimbursements from the jurisdiction based on associated direct costs of conducting their election. Approximately \$16,500 of election costs will be reimbursed by the Palo Verde Community College District.

RESOLUTION CONSTITUTING ORDER OF SPECIAL ELECTION TO FILL VACANT SEAT ON THE GOVERNING BOARD OF THE PALO VERDE COMMUNITY COLLEGE DISTRICT, RIVERSIDE COUNTY, CALIFORNIA

WHEREAS, Education Code section 5090 provides that a vacancy is created on a school district governing board upon the occurrence of any of the events specified in Government Code Section 1770; and

WHEREAS, in December of 2016, Debra A. Mitchell was elected to the Governing Board of the Palo Verde Community College District as a Board Member pursuant to Education Code section 5000, and Board Policy 2100; and

WHEREAS, on January 9, 2019, a vacancy was created on the Governing Board of the Palo Verde Community College District, within the meaning of Education Code section 5090 and Government Code section 1770(c) when Board Member Debra A. Mitchell passed away; and

WHEREAS, Government Code 1770 and Education Code 5091(a) state that upon a vacancy of a Board member position, the Board has the option to either order an election or make a provisional appointment. (Govt. Code § 1770(c) and EC 5091(a)); and

WHEREAS, there are 146 days between the date of the vacancy on January 9, 2019, and the date of the next regularly scheduled election on June 4, 2019, entitling the Board to fill the vacancy at the election on June 4, 2019; and

WHEREAS, pursuant to Education Code 5093(b) a vacancy goes unfilled until a person is elected at a special election which is consolidated with the next regularly scheduled election, that being June 4, 2019, at which time both a special election and general election will be scheduled.

WHEREAS, pursuant to Education Code section 5091(e), a person elected to fill a vacancy on a school district governing board shall hold office for the remainder of the unexpired term created by the vacancy; and

WHEREAS, Board Member Mitchell's term on the Governing Board of the Palo Verde Community College District would have otherwise ended in December of 2020; and

WHEREAS, pursuant to Education Code Section 5091(g), special elections held pursuant to Education Code section 5091(c) shall be conducted in nearly the same manner as practicable as other governing board member elections; and

WHEREAS, pursuant to Education Code section 5322, a county superintendent of schools may concurrently designate the date and purpose of an election with an order of election, otherwise known as the "specifications of the election order";

THEREFORE, BE IT RESOLVED, the Board of Trustees of the Palo Verde Community College District hereby elects to order a special election on June 4, 2019, to be consolidated with the regular scheduled all mail ballot election, in accordance with Government Code section 1770 and 1770(c), and Education Code sections 5090, 5093(b), 5091(a), 5000, 5091(e), 5091(g), 5091(c) and Board Policy 2100 to fill the vacancy created by the passing of Trustee Mitchell.

BE IT FURTHER RESOLVED that, pursuant to Education Code section 5322, the PALO VERDE COMMUNITY COLLEGE DISTRICT specifications of the election order are as follows:

The special election shall be held on June 4, 2019, and shall be an all mail ballot election in accordance with Elections Code 4004;

The purpose of the special election is to fill the vacancy created by the passing of Board Member Debra A. Mitchell on January 9, 2019;

The term of the vacant Board position shall expire in December of 2020.
