


BACKGROUND:

Summary

On Tuesday, October 23, 2018, the Board of Supervisors approved item 3.32 adopting Resolution Nos. 2018-203 and 2018-204. Those resolutions established the Salton Sea Enhanced Infrastructure Financing District and the Salton Sea Enhanced Infrastructure Financing District Public Financing Authority.

As required by Section 53398.59(f) of the Government Code, Resolution No. 2018-203 fixed a time and place for a public hearing on the proposed enhanced infrastructure financing district. Prior to that public hearing, a proposed infrastructure financing plan must be prepared in accordance with the requirements of Section 53398.63 of the Government Code. The public hearing is currently scheduled to take place on June 11, 2019 at 10:00am at the North Shore Beach and Yacht Club, 9115 Sea View Drive, Mecca, California. However, more time is required to prepare the proposed infrastructure financing plan and to provide notice to the affected landowners. Our recommendation is to postpone the meeting until October 15, 2019 at 11:00am at the North Shore Beach and Yacht Club, 9115 Sea View Drive, Mecca, California.

10 adopted Resolution No. 2018-203, in which resolution the board proposed to establish the Salton Sea
11 Enhanced Infrastructure Financing District; and,

12 WHEREAS, in said resolution, the Board of Supervisors fixed June 11, 2019 at 10:00am at
13 the North Shore Beach and Yacht Club, 91155 Sea View Drive, Mecca, California, as the time and place
14 for a public hearing on the proposal as required by Section 53398.59(f) of the Government Code; and,

15 WHEREAS, additional time is required to prepare the proposed infrastructure financing
16 plan pursuant to Section 53398.63 of the Government Code, which plan must be prepared prior to the
17 public hearing;

18 NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the
19 Board of Supervisors of the County of Riverside, in regular session assembled on May 21, 2019, at
20 9:00am or soon thereafter in the meeting room of the Board of Supervisors located on the 1st floor of the
21 County Administrative Center, 4080 Lemon Street, Riverside, California, as follows:

22 Section 1. The public hearing on the proposed Salton Sea Enhanced Infrastructure
23 Financing District is hereby postponed until October 15, 2019 at 11:00am at the North Shore Beach and
24 Yacht Club, 91155 Sea View Drive, Mecca, California.

25 Section 2. The Board of Supervisors hereby directs the County Recorder to mail a copy of
26 this resolution to each owner of land within the boundaries of the Salton Sea Enhanced Infrastructure
27 Financing District and to each affected taxing entity (as that term is defined in Section 53398.51 of the
28 Government Code).




