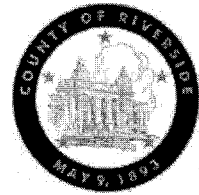





BACKGROUND: Community Improvement Designation Funds will be allocated to twenty-two (22) 2019 high school graduates who have served on the Second District Youth Advisory Council.

The scholarship award is designed to reward Second District Youth Advisory Council Members (YAC) for their hard work and to assist them with their education, which will improve our community.

Eligibility considerations are as follows:

- a. Graduating seniors attending community colleges, public colleges or universities, private universities or eligible trade schools;
- b. Proof of high school graduation;
- c. Participated in all mandatory YAC activities;
- d. Served on the council a minimum of one year (scholarships are \$250.00 for each year served on the council).
