



**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. Voices for Children – \$5,000 the funding will be used to support the Court Appointed Special Advocate Program (CASA). The program pairs volunteer CASA's that advocate for children who are dependents of the Superior Court system.
2. Western Center Community Foundation - \$5,000 funds will be utilized for the Science Education Experience program at the Western Science Center, which promotes children learning about natural and cultural heritage of the region.
3. Riverside County Foundation on Aging - \$2,500 the funding will provide holiday grocery store gift cards for Third District low-income seniors to purchase holiday meals.
4. Murrieta Chamber of Commerce - \$1,000 the funding will be used for the Murrieta State of the City event. This event provides an avenue to communicate directly to the citizens of Murrieta as to current and future initiatives within the city.
5. Rose Again Foundation - \$3,000 the funding will be utilized for foster children who have been placed in foster care homes in the Southwest area. The Rose Again programs offer children clothes, shoes, school supplies and tutoring assistance.
