**BACKGROUND:**

**Summary**

The City of Riverside (City) would like to donate a 1998 Mighty Box 2-Axle Storage Trailer (Serial Number CA 749843) to the Emergency Management Department's Riverside County IMT3 Response Team. This trailer is no longer used by the City. Once title is transferred, the Riverside County Emergency Management Department will be responsible for the maintenance, repair, and replacement of the trailer, including new branding of trailer.

The City intended to use this trailer during major incidents and natural disasters and it was rarely used. Riverside County IMT3 Response Team desires to use this trailer to carry equipment that will be used locally throughout the County to respond to major incidents and natural disasters.

The trailer is identified as 1998 Mighty Box 2-Axle Storage Trailer (Serial Number CA 749843).


**Impact on Residents and Businesses**

19 assembled on June 18, 2019, at 9:00 A.M., or soon thereafter in the meeting room of the Board of  
20 Supervisors located on the first floor of the County Administrative Center, 4080 Lemon Street, California,  
21 authorizes and accepts the donation of one (1) 1998 Mighty Box 2-Axle Storage Trailer (Serial Number  
22 CA 749843), in favor of the County of Riverside.

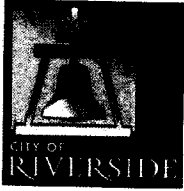
