BACKGROUND:

Summary

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the June 4, 2019 City of Riverside General Municipal Mail Ballot Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On April 30, 2019, the Board of Supervisors approved the conduct of election services for the City of Riverside General Municipal Mail Ballot Election. Election costs fully reimbursable from the City of Riverside are approximately \$241,000.

The election was successfully held on June 4, 2019 with _____% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast for the City of Riverside General Municipal Mail Ballot Election.

Impact on Residents and Businesses

Registered voters in the City of Riverside had the opportunity to vote for Councilmembers of Wards 1, 3, 5 and 7.

Additional Fiscal Information

As approved by the Board of Supervisors on April 30, 2019, the County will receive reimbursements from the jurisdiction based on associated direct costs of conducting their election.
