

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. San Geronio Pass Historical Society: These funds will help support the fundamental function of a historical society by supplying archival materials and oral history documentation equipment. This would improve the quality of life for residents who are interested in their community, city, and county history.
2. Mt. San Jacinto Foundation: The funding will support the MSJC Foundation Scholarship Program that provides scholarships to students. In addition, the funds will support the Champions of Tomorrow and the MSJC Foundation's annual events that improve the quality of life for students and assist with fund raising opportunities.
3. Riverside Humane Society dba Mary S. Roberts Pet Adoption Center: This funding will support the efforts to reduce the over population at the Riverside County shelters and help transition pets to a new home. In addition, it will contribute to paying the cost of spay and neuter and decrease the overall amount of stray animals in the community.
4. Riverside Art Museum: The funding will support the Cheech Marin Center for Chicano Art, Culture and Industry that aims to highlight and showcase the accomplishments of Latino artists. The funding will provide support for the preservations in history, art and culture.
5. Perris Valley Historical and Museum Association: These funds will support the day to day operations of the association through archival supply purchase. Exhibition displays and creation. It will significantly benefit the general public through its historical preservation.

6. Meniffee VFW Post 1956: The Veterans of Foreign Wars aims to establish a Cyber Patriot computer lab at Paloma Valley High School in the Computer Science Department. These funds will help purchase computer hardware and programs to train students on counter defense in the cyber platform.
7. City of Moreno Valley, Emerging Leaders Council: These funds will help the yearly operations of the Emerging Leaders Council. The programs educates students in local and regional government policies and how it affects their communities. In addition, the Emerging Leaders Council will partner with the Youth Advisory Council on community events that will benefit residents of Riverside County.
