

Authorize the Clerk of the Board to advertise for bids to be received by the office of the Director of Transportation and Land Management at the Transportation Annex located at 3525 14th Street, Riverside, CA 92501. All bids must be received up to the hour of 2:00 p.m., Wednesday, July 17, 2019 at which time bids will be opened; and
4. Direct the Clerk of the Board of Supervisors to file the Notice of Exemption with the County Clerk for posting within five (5) working days.

BACKGROUND:

Summary

The Transportation Improvement Program (TIP) provides for the construction of the Whittier Avenue Resurfacing Project from San Jacinto Street to Old Agency Road, an approximately 2.3 mile segment, in the Community of East Hemet.

Roadway resurfacing is needed due to the deteriorated pavement conditions. The proposed project will include removing some of the existing asphalt by milling the roadway and reconstructing a new layer of Rubberized Hot Mix Asphalt (RHMA) over Hot Mix Asphalt (HMA).

Additional work includes the reconstruction of concrete curb and gutter, cross gutters, sidewalk, and driveways that are in poor condition. Eight existing curb ramps will be reconstructed to comply with the American with Disabilities Act (ADA) standards.

On April 28, 2017, Senate Bill 1 (SB-1) was passed to improve the state's aging transportation infrastructure, particularly roads and bridges. Because of this, the County is now able to improve the condition of roads in need of resurfacing or reconstruction and has included them in the County's TIP. Whittier Avenue resurfacing project is one of Riverside County's priority projects approved for use of the new Gas Tax/SB-1 funds. Without SB-1 this needed road repair project would have been shelved until funding became available.

A portion of Whittier Avenue is in the City of Hemet, the southerly half of the street from 200 feet east of San Jacinto Street to 580 feet easterly. The City of Hemet has been invited to participate in the project, and work within the City of Hemet is specified in Alternate Bid Schedule 1. If the low bid is approved and concurred to by the City of Hemet, a Reimbursement Agreement between the City of Hemet and the County of Riverside will be entered into by the City of Hemet and the Board of Supervisors prior to or concurrent with the award of the construction contract.

The submitted plans and specifications have been approved as to form by County Counsel.

The bid documents include the following bid schedule of work:

The Transportation Department will select the contractor based upon the lowest responsive and responsible bid of the sum of all bid schedules.

Environmental Findings

The proposed project is exempt from CEQA under Section 15301 (c) because the resurfacing of the road and additional safety improvements do not create additional traffic lanes and involve negligible or no expansion of existing or former use of the existing roadway and associated facilities.

Impact on Citizens and Businesses

The purpose of this project is to rehabilitate a deteriorated segment of Whittier Avenue, totaling approximately 2.3 miles, to provide the public with a smooth paved roadway that will improve the safety and efficiency of vehicular traffic.

The work is scheduled to begin in the fall of 2019. The work will be phased to keep the road open during construction as much as possible and will take approximately three months to complete.

Additional Fiscal Information

The construction contract is estimated to cost approximately \$2,615,690 and will be funded with Gas Tax/SB-1 funds and City of Hemet funds, if the City of Hemet chooses to participate.

There are no General Funds used in this project.

PROJECT DESCRIPTION: The Riverside County Transportation Department (RCTD) is proposing to resurface approximately 2.3 miles of Whittier Avenue from 200 feet east of San Jacinto Street to 500 feet east of Old Agency Road. Whittier Avenue is classified as a Secondary Highway in the County of Riverside's General Plan. Whittier Avenue currently ranges from 20-66 feet in width with dike, rolled berm, and curb/gutter along various segments of the roadway. The proposed project will include the following:

- Removal or pulverization of the roadway, followed by overlay with Rubberized Hot Mix Asphalt (RHMA) over Hot Mix Asphalt (HMA)
- Pulverization and overlay of dirt shoulder
- Construction of curb ramps, curb/gutter, dike, and driveways
- Reconstruction of non-ADA compliant curb ramps, damaged concrete improvements (curb/gutter, sidewalk, cross gutter, spandrel), dike, berm, and driveways
- Placement of safety edge and shoulder backing
- Striping of roadway, pavement marker and reflectors
- Utility adjustments
- Tree/vegetation trimming

ENVIRONMENTAL ANALYSIS:

The proposed project will be constructed within existing County right of way. Temporary construction easements will not be required for the proposed improvements. Portions of the project improvements will be outside of the existing traveled way in order to pulverize and overlay the dirt shoulder. The project will raise the existing roadway profile by 0.40 feet in the segments that will be pulverized and overlaid.

This project is subject to compliance with the Western Riverside County Multiple Species Habitat Conservation Plan (MSHCP). In accordance with Section 7 of the Western Riverside County MSHCP, necessary operation and maintenance activities along existing roadways are considered covered activities outside of cell criteria areas. The proposed project is an operation and maintenance activity conducted for safety purposes that is located outside of cell criteria areas, therefore it is a covered activity under the Western Riverside County MSHCP.

If tree and/or vegetation removal takes place during the migratory bird breeding season (March 1st – September 1st), a preconstruction nesting survey will be conducted pursuant to the Migratory Bird Treaty Act (MBTA).

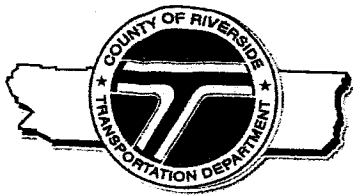

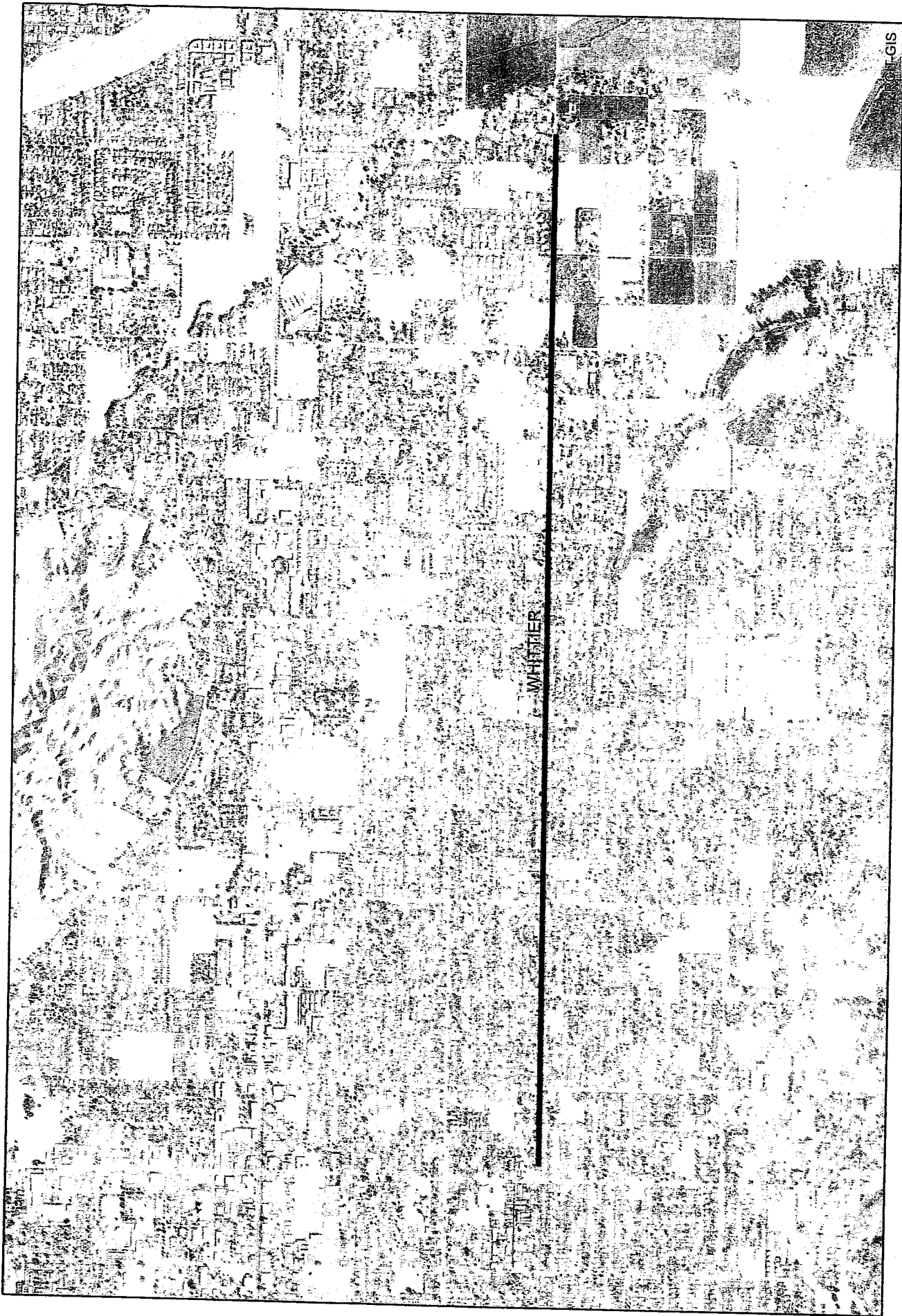

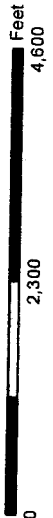
