

***SUBJECT: Approval of FY 19/20 Budget Amendments & Resolution of Adoption***

---

Board members:

As we continue to transform Riverside County government, I want to recognize departments for coming together to make the necessary adjustments to finalize this year's budget. Some requests for additional NCC from the prior year were decreased, while other departments' ongoing NCC was reduced. Additionally, some departments have been asked to reevaluate and pursue new revenue opportunities.

The county must continue to progress towards our shared mission, vision and set of goals to ensure the long-term fiscal sustainability for our county, and the health, welfare and safety of our residents. All of this must be achieved while implementing strong cost controls. Hard decisions must be made while we balance the county's priorities and the increased strain for services. This task is an absolute reality that all county departments and agencies must adopt and apply.

### **The Recommended Budget**

On June 10, 2019, I presented the Board a FY 19/20 recommended budget that provides \$6.1 billion in overall spending authority and \$3.5 billion for general fund operations. This includes \$838 million in discretionary general fund spending funded by \$838 million in general-purpose revenue, and \$20 million in contingency funded by one-time revenue opportunities. The proposal included a multi-year discretionary spending plan with targeted cuts to certain general fund departments' FY 19/20 net cost allocations to keep discretionary spending within the reserve limits set by the Board.

Also included is funding for IHSS, General Assistance, the phased opening of the John J. Benoit Detention Center, inmate healthcare settlement costs, the medical office building for RUHS, Community Health Centers, the new property tax system, and various pending obligations as previously presented to the Board. In crafting the recommended

budget, my office took a number of steps aimed at containing costs and minimizing further deficit spending.

### **Budget Hearings**

On June 10 and 11, the Executive Office overview stated my office's recommendations to provide additional net county cost funding in the amount of \$29 million, offset by targeted cuts of \$21 million. The Board took testimony from departments and the public regarding spending needs and operational challenges. Specifically, the Board sought to address the request by Cooperative Extension for \$562,064, with the current budget of \$112,000, funding would be brought back to the prior year allocation of \$674,064. The Board members' also raised concerns about service levels in Code Enforcement and proposed restoring \$500,000.

Budget Hearings were continued to June 18 where the Board requested to include the reinstatement of a \$1 million cut to EDA – Economic Development Programs as well as an increase of \$500,000.

To ensure baseline-spending authority for FY 19/20 was in place by June 30, as required by law, the Board approved the Recommended Budget as presented and asked the Executive Office to return with the final recommendations requested during budget hearings.

### **Revised Recommendations**

As discussed above, the recommendation is to now restore \$562,064 for Cooperative Extension, \$500,000 for Code Enforcement, and \$1.5 million for EDA - Economic Development Programs. These total \$2.6 million in ongoing discretionary spending.

The net discretionary spending increases recommended at this time are summarized below:

	<b>\$ in millions</b>

These spending increases are covered in the near term by reductions in appropriations for contingency in FY 19/20 until general-purpose revenues rise sufficiently to sustain this long-term. If revenues do not materialize this will impact fund balance.

The recommendations contain certain technical adjustments to be included in the Adopted Budget, including the reduction of budgets for EDA Maintenance, Custodial, Real Estate and Project Management Office that were inadvertently left out of the book.

Also included is a separate motion for approval of Ord 440-9117 including five positions for Code Enforcement as part of the reinstatement of \$500,000.

### **Multi-Year Impact**

The spending increases recommended above are projected to keep us on the path to structural balance and maintaining reserves above the \$150 million level. This is achieved by offsetting these spending increases with draws on general fund contingency, leaving a remaining balance of \$17.4 million to begin the year. Also, pending labor negotiations could potentially change the multi-year strategy if on-going funding sources are not achieved.

As we implement more cost-effective operations, we may see more flexibility in our options. However, until then, we must use discipline and collaboration to address the rising demand for services within these financial constraints.

**IT IS THEREFORE RECOMMENDED** that the Board of Supervisors:

Please don't support us losing San Jacinto Valley Animal Campus shelter! We don't want our animals to be sent 40+ miles away! This means more crowding at already high kill shelters, less residents able to retrieve their pets, no more kitten/puppy foster program that saved so many underage babies that would have been euthanized by law because they were under 8 weeks of age, no more low cost spay/neuter/vaccines/microchips, likely higher licensing fees and ultimately and most importantly, this will increase the euthanasia rates that are already too high!

The Riverside shelter is a beautiful facility but please do not let that facade fool you. Please let the statistics of their euthanization rates tell the truth about what really goes on there, not to mention over 3/4th of the animals are not accessible to the public eye. How can an already high kill shelter handle more animals? It already has a 75% kill rate for cats? Please take a moment to look at the static's for all types of animals there and at Thousand Palms which are both being considered to send the SJVAC animals to.

I have pulled huskies from Riverside that are marked "rescue only" due to being evaluated as aggressive and they are not...I have pulled dogs from there that have had microchips linked to owners who wanted them, etc...that were missed or perhaps not even scanned..How can a shelter who can not seem to hire qualified people to evaluate animals or check microchips correctly handle that many more animals? I have also been a long time volunteer for them and am just not impressed and know things I wish I did not know. This shelter needs to shape up and be responsible enough to not take on more animals that it can not handle. Plus over 3/4ths of the Jurupa Valley shelter's animals are out of the public's view! Very few of the majority of the animals there are even on the adoption floor and available for the public to see.

Also, I currently run the Banning, CA Lost and Found Page and see first hand how difficult it is for people to retrieve their lost pets that are transferred so far away and out of their city. (Our Banning pets currently go to San Jacinto Valley Animal Campus which is approximately 17 miles away.) The return to owner ratio has gone way down since they have been shipped over to another city and it will inevitably be worse sending 40+ miles!

Please, please help our local animals by not shutting down San Jacinto Valley Animal campus.

Hello Board of Supervisors,

It is understandable why the board is considering closing San Jacinto Animal Campus as there is no easy solution to this budget crisis. However, housing these animals at the Riverside Facility will significantly increase costs due to:

1. Animals are less likely to be found by their owners leading to longer lengths of stay and higher euthanization rates
2. Cost of gas and wear on animal control trucks
3. Greater likelihood of disease transmission, leading to higher medical costs
4. Higher euthanasia rates due to overcrowding
5. Higher rates of burnout and injury by staff as they take on the increased workload
6. July is the busiest time of year for animal shelters, so this is the worst time for San Jacinto to close.  
**Even if it can be delayed by a few months, this will significantly help with the transition.**

## Ideas to Reduce Cost:

The key to reducing cost in animal shelters is to reduce length of stay and to reach out to the community. Below are some ideas:

1. Engage in fundraisers and encourage donations. Most of San Diego Humane Society's funding comes from donors. It will take years to create the relationships necessary to receive funding close to what SDHS receives, however the benefits would be enormous. Below is the income breakdown for SDHS:

2. Innovative low cost programs such as a Doggie-Day Out Program or other short-term foster programs. The Doggie-Day out program allows volunteers to take well-behaved adoptable dogs to outside locations to be adopted. A large non-profit organization called Maddie's fund also has other innovative ideas, as well as grants available for various programs.

3. Post information newspapers and in local businesses about available pets or events. Encourage volunteers and visitors to share social media posts. Some newspapers will post ads for free if there is unused ad space. Volunteers can be asked to distribute flyers as it would be cost-intensive for staff to do so.

4. Create a Lost Pet detective volunteer team like Washoe County did. These volunteers can look for lost pet posts on social media and craigslist. They can then leave a comment with a link to the animal's petharbor profile. A surprising amount of people don't regularly check the shelters for their pet so this can help get pets home.

5. Utilize volunteers for off-site events. This can increase shelter publicity and increase adoptions.

6. Create opportunities for visitors to post fun stories on social media to improve the communities awareness of their shelter. Have an area where they can pose for a picture they can then post on social media. This would improve the communities awareness of the shelter. Create a scavenger hunt where visitors look for pictures posted around the campus. If the Huey's reading program still hasn't returned to San Jacinto, then SJVAC can create their own in-house reading program for kids.

7. Find methods to increase the amount of animals returned in the field.

I am a Menifee resident and I am begging you to do the right thing and please do not close down the San Jacinto animal shelter. My dog Mylo is currently lost and this is devastating news. As it is, we have been going back and forth from the Wildomar to the San Jacinto. In fact, one good samaritan thinks they turned in my dog on Friday and I have been trying to locate him.
